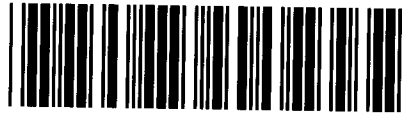

**ORDER NO. 7  
GRANTING EXTENSION AND ADOPTING AMENDED PROCEDURAL SCHEDULE**

On April 24, 2015, Order No. 6 was issued, requiring Crystal Clear Water Supply Corporation and the City of San Marcos (collectively, Applicants) to provide revised mailed and published notice, establishing deadlines, and granting a good-cause extension of the one-year deadline in 16 Tex. Admin Code § 24.112(e) (TAC) from June 5, 2015 to July 31, 2015. On July 13, 2015, Public Utility Commission of Texas (Commission) Staff and the Applicants responded to Order No. 6, reporting that Applicants have not filed closing documents nor information regarding disposition of customer deposits as required by 16 TAC 24.109(g) and requesting a second good-cause extension of the one-year deadline.

It is Commission Staff's position that because the Applicants are diligently working to complete the transaction and provide the required documents good cause exists to extend the one-year deadline again. Commission Staff proposed an amended procedural schedule based on a second extension of the one-year deadline.

Consistent with Commission Staff's recommendation, the joint request for a second good-cause extension of the one-year deadline in 16 TAC § 24.112(e), from July 31, 2015 until September 25, 2015, is granted. The amended proposed procedural schedule is approved as proposed and shall apply to this proceeding:


Deadline for Applicants to file Bill of Sale and Information regarding Disposition of Customer Deposits	August 13, 2015
Deadline for Commission Staff to file a Final Recommendation on the Application	August 27, 2015
Deadline for Commission Staff to file a Proposed	September 10, 2015
