## **LOMETA CONFIRMATION AND SUPPLEMENT AGREEMENT**

THIS LOMETA CONFIRMATION AND SUPPLEMENT AGREEMENT (the "Lometa Confirmation Agreement") by and between the LOWER COLORADO RIVER AUTHORITY, a conservation and reclamation district and political subdivision of the State of Texas ("LCRA"), and CORIX UTILITIES (TEXAS) INC., a Delaware corporation ("Buyer"), is made and entered into this 15th day of August, 2013.

### **RECITALS**

#### **WHEREAS:**

- A. LCRA and Buyer are parties to that certain Utilities Purchase and Sale Agreement with an Effective Date of March 30, 2012 (the "PSA") as amended by the Confirmation and Supplement Agreement between the parties dated October 1, 2012 (the "First Confirmation Agreement"). Collectively, the PSA and the First Confirmation Agreement are referred to herein as the "Agreement."
- B. Pursuant to Section 8.12 of the Agreement, and estoppel letters issued by LCRA in respect thereof, Buyer possesses the right to confirm the Agreement as it relates to the City of Lometa water system and wastewater system (together, "Lometa") on or before August 15, 2013.
- C. Pursuant to the escrow agreement dated October 15, 2012, among the parties and The Bank of New York Mellon as escrow agent (the "Escrow Agreement"), an initial earnest money deposit in the amount of \$168,246.62 was made on October 15, 2012, and if the Buyer provides confirmation in respect of Lometa, a second deposit in the amount of \$306,753.38 (the "Second Deposit") must be made by the Buyer.
- D. Buyer and City of Lometa (the "City") have agreed and LCRA and Buyer hereby agree under a term sheet dated July 31, 2013 (the "Term Sheet"), that, subject to Texas Commission on Environmental Quality ("TCEQ") approval and entry by Buyer and the City into a franchise agreement containing a right of first refusal and purchase option, the Potable Water Assets and Wastewater Assets (as defined in the Term Sheet) will be purchased by Buyer from LCRA and the Raw Water Assets (as defined in the Term Sheet) will be leased by Buyer from LCRA, under a 15-year lease containing a purchase option (the "Lease").
- E. Under this Lometa Confirmation Agreement, Buyer wishes to confirm the Agreement as it relates to Lometa and LCRA wishes to accept Buyer's confirmation of the Agreement under the terms and conditions contained herein, it being acknowledged and agreed by Buyer and the LCRA that Buyer's confirmation is expressly conditioned upon the agreement and amendments contained in this Lometa Confirmation Agreement.

NOW, THEREFORE, in consideration of the mutual covenants hereafter set forth and other good and valuable consideration, the parties hereto agree as follows:

**1. General**

- 1.1. **Definitions.** Unless otherwise specified or defined herein, capitalized terms shall be afforded the definitions provided to same in the Agreement, and if not defined in the Agreement, then in the Term Sheet.
- 1.2. **Headings.** Descriptive headings are for convenience only and shall not control or affect the meaning or construction of any provision of this Lometa Confirmation Agreement.
- 1.3. **Appendices.** The following appendices are attached hereto and incorporated herein for all purposes and, to the extent applicable, such appendices shall amend and restate the referenced Schedules to the Agreement as they relate to (and only as they relate to) Lometa.

**2. Confirmation**

By this notice to LCRA, Buyer confirms the Agreement subject to the updates provided pursuant to Section 8.12 and the terms and conditions hereof and will deposit the Second Deposit further to Section 3.3A of the Agreement and the terms of the Escrow Agreement.

- 2.1. **LCRA Waiver.** Except in respect of Schedule 3 to Exhibit A and Lometa Exhibit G Update, LCRA waives any further right to update Schedules and Exhibits under Sections 8.12(a) and 8.12(b) of the Agreement.
- 2.2. **Buyer Confirmation and LCRA Acceptance of Confirmation.** Buyer confirms the Agreement in respect of Lometa, as supplemented and modified by this Lometa Confirmation Agreement, and LCRA hereby accepts Buyer's confirmation of the Agreement in respect of Lometa.
- 2.3. **Confirmation Date.** The Confirmation Date under the Agreement for Lometa is the date of this Lometa Confirmation Agreement.

### **3. Restructure of Lometa Asset Transfer**

#### **3.1. Confirmation of Term Sheet**

The parties confirm their agreement to the Term Sheet attached hereto as Appendix 1, and agree that the terms thereof relating hereto are incorporated herein and form a part of this Lometa Confirmation Agreement.

#### **3.2. Restructure of Purchase**

In accordance with the Term Sheet, the parties confirm that they have agreed to structure the transfer of the Lometa Raw Water Assets as a long-term operating lease with a raw water asset purchase option rather than a direct purchase, with the agreed-upon lease amounts and revised purchase price allocation attached hereto as Appendix 2.

#### **3.3. Amendment of the Agreement**

The parties therefore agree that the Agreement is consequentially amended to reflect the revised transfer structure and purchase price allocation for the Lometa utility assets as set out in this Lometa Confirmation Agreement, and the parties agree to take any further steps and execute any further documents necessary to formalize such amendment including applicable provisions of the Term Sheet (Appendix 1).

### **4. Updates to the Agreement and Schedules**

#### **4.1. Description and Identification of Assets**

- (a) “Exhibit A, Schedule 3 – Tracts” of the Agreement, as amended by Appendix 3.1(a) to the First Confirmation Agreement, is hereby confirmed complete and correct in respect of the Lometa tracts, and a copy of the still-current list of the Lometa tracts is attached hereto for reference as Appendix 3.
- (b) “Exhibit A, Schedule 3 – Easements” of the Agreement, as amended by Appendix 3.1(a) to the First Confirmation Agreement, is further amended by the deletion of the outdated list of Lometa easements (at page 10 of the Schedule 3, starting with Easement ID WE0000437 and ending at WE0000439) and replacement by the updated list of Lometa easements set out in the “Updates to Exhibit A, Schedule 3 – Lometa Easements” dated August 12, 2013, attached hereto as Appendix 4.
- (c) Pursuant to Section 8.12(c) of the Agreement as amended by Section 2.1 of the First Confirmation Agreement, LCRA provided Buyer with the first Lometa Exhibit G Update on October 30, 2012, attached hereto as Appendix 5, and LCRA has provided the further updated Lometa Exhibit G Update (the “Easement Deficiency List”) as of August 9, 2013, attached hereto as Appendix 6.

#### **4.2. Asset Review and Regulatory Review Period**

In accordance with the Term Sheet and further agreement of the parties, the Asset Review Period and Regulatory Review Period for Lometa Assets shall be consistent with the terms of the Agreement with, in respect of the Lometa Assets only, the following exceptions:

- (a) the "Lometa Asset Review Period" shall be the *later* of (1) 180 days from the effective date of this Lometa Confirmation Agreement or (2) the end of the Lometa Regulatory Review Period; and
- (b) subject to the filing of STM Applications for the other utility systems in Hill Country and South East Region, Buyer will make commercially reasonable efforts to submit its STM Application with respect to the Utility Assets on or before August 30<sup>th</sup>, 2013, and undertake its additional real estate and environmental due diligence concurrent with the Regulatory Review Period for Lometa.

#### **4.3. Real Estate , Health, Safety and Environmental Matters:**

- (a) The parties confirm that, under the Term Sheet, rights and obligations relating to real estate in respect of Lometa are to be consistent with the Agreement, as amended by this Lometa Confirmation Agreement, including requirements for title commitments and valid easements in respect of properties associated with the Potable Water and Wastewater Assets, and rights of access and confirmation of title commitments and valid and transferrable easements and property title associated with the Raw Water Assets for the purposes of the Lease and the Raw Water Purchase Option. The parties acknowledge and agree that Appendices 3, 4 and 6 cumulatively describe the Property for both the Potable Water and Wastewater Assets as well as the Raw Water Assets, and that the Property for the Potable Water and Wastewater Assets will be conveyed to Buyer at Closing in accordance with the Agreement, as amended by this Lometa Confirmation Agreement, whereas the Property for the Raw Water Assets will be leased to Buyer on the Closing Date in accordance with terms contained in this Lometa Confirmation Agreement and the Term Sheet.
- (b) The parties confirm that, under the Term Sheet, rights and obligations relating to health, safety, and environmental matters in respect of Lometa are to be consistent with the Agreement, including requirements for ASTM Compliant Phase I ESAs and satisfactory OSHA audits of the Utility Assets including the Raw Water Assets.

#### **4.4. Supplemental Buyer's Conditions**

In addition to the Buyer's conditions to Closing set out in Section 9.4 of the Agreement, Buyer shall have no obligation to Close unless and until at Closing:

- (a) Buyer, at its sole cost and expense has procured a commitment for title insurance further to Section 4.6 of the Agreement for the Property highlighted in green on the attached Appendix 3 or 4 (the "Core Lometa Easements"), except the title and

survey review period shall continue beyond the expiration of the Lometa Asset Review Period and all of Buyer's rights shall continue pursuant to Section 4.6 of the Agreement as to all Core Lometa Easements.

- (b) LCRA, at its sole cost and expense shall obtain public utility easements, rights-of-way or other appropriate real property rights identified in the Easement Deficiency List, in accordance with Sections 4.5 and 4.6 of the Agreement except the title and survey review period shall continue beyond the expiration of the Lometa Asset Review Period and all of LCRA's obligations shall continue pursuant to Section 4.6 of the Agreement as to all Properties listed on the Easement Deficiency List. No costs and expenses expended by the Seller under this Section 4.4(b) shall constitute Permitted Capital Expenditures or otherwise be comprised in the Purchase Price. All costs and expenses incurred in connection with LCRA curing any Easement Deficiencies will be borne entirely by LCRA. The foregoing shall include title abstracts or reports and surveys of such easements, rights-of-way, or other real property rights in compliance with the survey requirements set forth in the Survey Requirements appendix to the First Confirmation Agreement for all Property except for the Property that is not highlighted in green (the "Non-Core Lometa Easements"). For the Non-Core Lometa Easements, LCRA may acquire easements in the form of as-built easements but shall provide Buyer by delivery from LCRA, recording information, copies of the deeds and copies of any applicable pre-existing surveys for the Non-Core Lometa Easements together with a title abstract or report of any and all encumbrances that affect these easements. All costs and expenses incurred in connection with any such surveys or title commitments will be borne entirely by LCRA. Buyer shall have a review and an objection period of sixty (60) days from the date of the receipt of the last of the surveys, title abstracts or reports, exception documents, and deeds provided by LCRA pursuant to this paragraph. Nothing in this paragraph 4.4(b) shall prevent the parties from agreeing to alternative terms, conditions and details relevant to easements, rights-of-way, or other real property rights for the Lometa water and wastewater utility systems in the event Buyer reaches agreement with the City of Lometa, Texas, for the City to acquire those systems without the parties having to formally further amend the Agreement.

## 5. Miscellaneous

- 5.1. Effect of the Confirmation. Except as specifically modified by this Lometa Confirmation Agreement, all of the other terms and provisions of the Agreement shall remain in full force and effect, unmodified by this Lometa Confirmation Agreement, and are hereby ratified and confirmed by the parties as of the date of this Lometa Confirmation Agreement. Notwithstanding the foregoing, in the event there is any conflict between the terms and provisions of the Agreement and this Lometa Confirmation Agreement, the terms and provisions of this Lometa Confirmation Agreement shall control. Upon the effectiveness of this Lometa Confirmation Agreement, each reference in the Agreement to "this Agreement", "hereunder", "hereof" or words of like import referring to the Agreement shall be a reference to the Agreement as amended hereby.



TERM SHEET

**LOMETA FRANCHISE AGREEMENT (LOMETA-CORIX) / LOMETA CONFIRMATION AGREEMENT (LCRA-CORIX)**  
**JULY 31, 2013**

This Term Sheet is not intended for use in any proceeding, including any proceeding involving participating parties. This Term Sheet outlines the key terms and conditions between the City of Lometa ("Lometa"), Corix Utilities (Texas) Inc. ("Corix") and the Lower Colorado River Authority ("LCRA") with respect to (i) a confirmation agreement related to sale and purchase of the water and the wastewater utility systems in Lampasas County between LCRA and Corix (the "Confirmation Agreement") and (ii) the establishment of a new Franchise Agreement between Corix and Lometa that will allow Corix to undertake the regulated water and wastewater utility business within Lometa (the "Franchise Agreement"). It is proposed that Corix and Lometa will enter into a binding Memorandum of Agreement on or before August 15, 2013, which will allow Corix to proceed with the completion of its due diligence and submission of its Sales, Transfer, Merger Application ("STM") to the Texas Commission for Environmental Quality ("TCEQ") for regulatory approval to acquire these water and wastewater utility assets from LCRA.

The water and wastewater utility assets consist of;

- (1) the intake, supply main, dam, reservoir and associated water rights (the "Raw Water Assets"),
  - (2) the water treatment plant, potable water distribution system, the Grumble Water Lease and Miller Water Lease, and the associated Certificates of Convenience and Necessity (the "Potable Water Assets"),
  - (3) the sewer collection system, wastewater treatment plant, solar power array and the associated Certificate of Convenience and Necessity (the "Wastewater Assets")
- (the Potable Water Assets and the Wastewater Assets, plus the Raw Water Assets if Corix exercises its purchase option as contemplated herein, including all Betterments and Improvements as defined herein, are referred to herein the "Utility Assets").

**CORIX - CITY OF LOMETA FRANCHISE AGREEMENT**

**Franchise Term:** The Term of the Franchise Agreement shall be 50 years. Corix shall be able to operate its regulated utility business and have public right of way access for the Utility Assets within Lometa.

**Effective Date:** The Effective Date shall commence on the closing date of the sale and purchase of the utility assets between LCRA and Corix, at which time the Franchise Agreement with LCRA shall terminate.

**Lometa Purchase Option:** Lometa shall have an option to purchase the Utility Assets on and after the Option Date (defined as the 40<sup>th</sup> anniversary of the Effective Date) to the end of the Term at the then current net book value of such Utility Assets for cash consideration. The Lometa Purchase Option shall continue and remain in full force and effect until the first to occur of Lometa exercising the purchase option or the 50<sup>th</sup> anniversary of the Effective Date. Lometa shall provide Corix eighteen (18) months advance written notice of its intention to exercise its Lometa Purchase Option.

**Franchise Renewal:** If at the end of the Term, Lometa has not exercised its Lometa Purchase Option, then Lometa and Corix shall enter into good faith negotiations for a new Franchise Agreement of not less than 25 years, provided however that any new Franchise Agreement shall not contain the Lometa Purchase Option and shall be on terms and conditions no less favourable than Franchise Agreement(s) from three cities in Central Texas representative of the size of Lometa. In the event the parties fail to reach agreement as to the terms of a new a Franchise Agreement, each party agrees to mediation.

**Option Reminder:** At least twenty (20) months prior to the expiry of the Franchise Agreement, Corix shall provide Lometa with a written reminder of (a) the Lometa Purchase Option and the form and timing of notification required for its exercise, and (b) the requirement, in the alternative, to commence discussions on renewal of the Franchise Agreement.

**Right of First Refusal:** Lometa shall have a 90 day Right of First Refusal at any time during the Term, following notification by Corix to Lometa of Corix's acceptance of a valid and binding offer to acquire the Utility Assets, on the same terms and conditions as offered to Corix. Such Right of First Refusal shall apply only to the sale of the Utility Assets and not to the sale, transfer or merger of Corix. Any such sale or transfer to a third party or affiliate shall be subject to the Lometa Purchase Option.

**Franchise fee and payment in lieu of property taxes ("PILOT"):** The PILOT shall be a payment in lieu of ad valorem property taxes by Corix to Lometa and shall also be and constitute the Franchise Fee payable to the City. It shall be equal to 8% of the revenues collected within the Lometa city limits for each of the water utility business and wastewater utility business. The aggregate of the PILOT and franchise fees payable to the City of Lometa shall not exceed 8% of revenues invoiced and actually collected. In the event City ad valorem taxes are assessed against the Utility Assets located within the City, Corix shall be entitled to deduct the amount of the City property taxes actually paid by Corix from the amount of the PILOT payable to the City.

The PILOT will be based on revenues received by Corix for service within the City at rates approved by the relevant regulatory authority. Since Lometa will be part of the Hill Country rate district, Corix will propose to the relevant rate setting authorities that the total annual PILOT be included in the overall cost of service and thereby distributed amongst all customers in Hill Country using a "postage stamp" rate approach.

**Corix Budgets and Capital Planning:** Corix shall annually consult with Lometa regarding the annual O&M budgets and 5-year Capital Plans for the Utility Assets, but does not require Lometa's approval of these budgets or plans. Corix shall provide to Lometa an annual projection of the estimated net book value(s) of each of the Raw Water Assets, Potable Water Assets and Wastewater Assets as at the Option Date.

**Rate Increases:** Corix shall not increase the utility rates for the first year following the Effective Date. Thereafter, Corix will phase in any initial rate increases over a minimum of a 3-year period. Changes in rates will be based on the regulatory process. Nothing in this agreement supersedes Lometa's original rate making jurisdiction rights.

**Rate District(s):** The water utility business (consisting of the Raw Water Assets and the Potable Water Assets) shall for rate making purposes remain part of the Hill Country Regional Water Rate District. The wastewater utility business shall for rate making purposes remain a stand-alone wastewater rate district.

**Other Matters:**

The Franchise Agreement shall be assignable by Corix to a third party with the consent of Lometa, such consent not to be unreasonably withheld. Corix will provide notification, but not require City consent, of any assignments by Corix to a wholly-owned subsidiary or another wholly-owned member of Corix's ultimate holding company.

Lometa agrees to support Corix's STM application and application regarding modifying the CCNs to include the Lometa Extraterritorial Jurisdiction ("ETJ") area identified on the maps attached hereto as Schedule 1 with the community and TCEQ.

Lometa waives any claims to any subsequent Right of First Refusal with respect to the sale by the LCRA, as a result of Corix and LCRA entering into the Lometa Confirmation Agreement which amongst other matters amends and restructures the contemplated transaction.

**Lometa Confirmation Agreement:** Corix and LCRA agree to enter into the Lometa Confirmation Agreement as outlined below and the Raw Water Asset Operating Lease as a condition to closing.

**CORIX – LCRA LOMETA CONFIRMATION AGREEMENT**

Corix and LCRA will execute a Lometa Confirmation Agreement, which amongst other matters contemplates amending and restructuring the purchase sale agreement, such that the Raw Water Assets are operated by Corix pursuant to a long-term operating lease, with a raw water asset purchase option rather than a direct purchase. The Potable Water Assets and Wastewater Assets are acquired for cash.

**Asset Review Period & Regulatory Matters:** The Lometa Confirmation Agreement will be consistent with respect to the Asset Review Period and submission of the STM application as agreed upon between LCRA and Corix pursuant to the utilities purchase and sale agreement with an effective date of March 31<sup>st</sup>, 2012, as amended and supplemented by a confirmation and supplement agreement dated October 1, 2012 and an amendment agreement dated November 16, 2012 (collectively the "PSA"), except for the following;

1. The Asset Review Period shall be the later of 180 days or the end of the Regulatory Period, and
2. Subject to the filing of the other STM applications for the utility systems in Hill Country and South East Region, Corix will make commercially reasonable efforts to submit its Sales, Transfer & Merger Application with respect to the Utility Assets on or before August 15th, 2013 and undertake its additional real estate and environmental due diligence concurrent with the regulatory approval process.

**Real Estate Matters:** The Lometa Confirmation Agreement will be consistent with respect to real estate matters as agreed upon between LCRA and Corix in the PSA, including but not limited to;

1. Title Commitments on the backbone assets associated with the Potable Water and Wastewater Assets,
2. Valid easements related to all of the properties associated with the Potable Water Assets or Wastewater Assets,
3. A Right of Access related to all of the Raw Water Assets and confirmation of title commitments, valid easements and/or property title related to the Raw Water Assets, that can be readily transferred free and clear of all encumbrances pursuant to the Raw Water Purchase Option.

**Environmental / HSE Matters:** The Lometa Confirmation Agreement will be consistent with respect to environmental matters as agreed upon between LCRA and Corix in the PSA, including but not limited to;

1. ASTM Compliant Phase 1 Environmental Site Assessment(s) of the Utility Asset properties, including the Raw Water Assets, by an independent third party engineering firm selected by Corix indicating no material environmental contamination. A copy of the Phase 1 ESA reports shall be provided to LCRA. To the extent any material environmental contamination is identified on any or the properties, LCRA shall have an opportunity to remediate the property at its own cost, such cost not to be recovered in the closing price adjustment. If

- LCRA determines that it will not remediate any contaminated property, it will be a basis for termination of the Lometa Confirmation Agreement and return of any Earnest Money; and
2. An audit by an independent third party engineering firm selected by Corix with respect to OSHA compliance of the Utility Assets, including the Raw Water Assets. To the extent the OSHA audit identifies OSHA regulations violations or deficiencies in the Utility Assets which are in aggregate greater than 5% of the purchase price of the Potable Water Assets, LCRA shall have an opportunity to remediate the OSHA violation at its on cost, but such cost not to be recovered in the closing price adjustment. If LCRA determines that it will not remediate any material OSHA violation, it will be a basis for termination of the Lometa Confirmation Agreement and return of any Earnest Money.

**Raw Water Asset Operating Lease:** The confirmation agreement shall provide that as a condition of closing, that LCRA and Corix shall prepare and execute a Raw Water Asset Operating Lease Agreement, based on the following general terms and conditions;

**Lease Term:** The Lease Term shall be 15 years commencing on the Effective Date. During the Term, Corix shall utilize the Raw Water Assets to provide raw water supply and storage in support of its regulated potable water utility business and have right of access to the Raw Water Assets. During the term of the lease, LCRA may not sell the Raw Water Assets to any other party unless it provides a right of first refusal to Corix. The Lease shall be assignable by Corix to a wholly-owned subsidiary or another wholly-owned member of its ultimate holding company; otherwise, Corix may assign the Lease only with LCRA's consent.

**Operating Lease Rents:** The annual rents payable by Corix to LCRA shall be as outlined by agreement between the parties and are subject to approval for recovery in rates by the relevant government authorities. The rents shall be payable monthly in an amount equal to 1/12<sup>th</sup> of the annual rental amount.

**Raw Water Asset Purchase Option:** Corix shall have an option to purchase the Raw Water Assets at the end of the fifteen (15) year Lease Term at a purchase price equal to \$3,000,000.

**Tax:** Each Party is responsible for its own independent tax advice with respect to the operating lease.

**Betterments and Improvements:** Corix shall annually prepare a 5-year capital plan with respect to the Raw Water Assets in consultation with LCRA. Corix shall fund, design, build and own any new assets constructed during the term of the lease (the "Betterments and Improvements").

**Water Rights and Water Diversion Permits:** LCRA shall retain all applicable water rights and water diversion permits until Corix exercises its Raw Water Asset Purchase Option. The Grumble Water Lease and Miller Water Lease shall be transferred to Corix as part of the Potable Water Asset purchase.

**O&M Standards:** During the Term, Corix shall be responsible to operate and maintain the Raw Water Assets in accordance with standards and procedures established by LCRA.

**Insurance:** Corix shall maintain commercial general liability insurance as would be typical for a utility operation of this nature and shall maintain property insurance covering the Betterments and Improvements. With regard to the Raw Water Assets, Corix and LCRA shall maintain

insurance for the Raw Water Assets consistent with the terms provided in the Operation and Maintenance Agreement made between Corix and LCRA on March 30, 2012, regarding other utility assets.


**Indemnifications:** Corix and LCRA shall exchange mutual releases and indemnifications with respect to any liability arising from the operations of the Raw Water Assets on the same terms provided in the Operation and Maintenance Agreement made between Corix and LCRA on March 30, 2012, regarding other utility assets.

**Termination:** In addition to the usual and customary termination provisions included in similar contracts, the Raw Water Asset Operating Lease will allow for termination in the event that the Potable Water Assets, or any part thereof, are expropriated by Lometa or any other entity with the right to exercise eminent domain over the Raw Water Assets. Further, in the case of termination for any reason, a termination fee equal to the aggregate of any unrecovered investments by Corix in respect of the Betterments and Improvements shall be paid by LCRA to Corix and Corix shall transfer title to the Betterments and Improvements to LCRA.

**Other Matters:** Corix seeks to have the recreational park adjacent to the Dam & Reservoir closed to the public in order to protect the source water supply and minimize continued O&M expense. LCRA will pursue this in cooperation with Corix in a timely manner.

**Lometa Franchise Agreement:** Corix and Lometa agree to enter into the Lometa Franchise Agreement as outlined above as a condition to closing.
