PROPOSED PROCEDURAL SCHEDULE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this Proposed Procedural Schedule. In support thereof, Staff would show the following:

I. BACKGROUND

On May 5, 2014, the City of Dorchester (Applicant or Dorchester) filed with the Texas Commission on Environmental Quality (TCEQ) an application (Application) to amend water Certificate of Convenience and Necessity (CCN) No. 12013 and decertify a portion of CCN 10150 in Grayson County pursuant to Tex. Water Code §§ 13.242 thru 13.250 (TWC) and 16 Tex. Admin. Code §§ 24.101 thru 24.107 (TAC). The Application was received by the Commission on October 1, 2014.

Order No. 14 instructed Staff to file a response to the Applicant's February 29, 2016 filing regarding notice.

II. PROPOSED PROCEDURAL SCHEDULE

Staff and the Applicant spoke to clarify notice concerns subsequent to the Applicant's February 29, 2015 filing. The conversation and information exchanged resolved the Applicant's notice concerns. Both parties agreed to following procedural schedule:

Deadline for the Applicant to file proof of notice, include affidavits, sample notice, and map.	March 24, 2016


CONCLUSION


