DEFINITIONS

 - b) Describe the economic need(s) for service in the requested area (i.e. plat approvals, recent annexation(s)or annexation request(s) building permits, septic tank permits, hospitals, etc.) and/or
 - c) Discuss in detail the environmental need(s) for service in the requested area (i.e failing septic tanks in the requested area, fueling wells, etc); <u>and/or</u>
 - d) Provide copies of any written applications or request for service in the requested area; and/or
 - e) Provide copies of any reports and/or market studies demonstrating existing or anticipated growth in the requested area. If no, please justify the need for service in the proposed area.
 - f) If none of these items exist or are available, please justify the need for service in the proposed area in writing.
