## WALTON TEXAS, LP'S SUPPLEMENT TO MOTION TO INTERVENE

Walton Texas, LP hereby files this Supplement to Motion to Intervene in the abovereferenced matter to address the City of Howe, Texas' Response in Opposition to Walton Texas, LP's Motion to Intervene.

As an initial matter, Walton Texas, LP notes that during the prehearing telephone conference held on May 20, 2016, the Administrative Law Judge specifically directed Walton Texas, LP to file a motion to intervene. The City of Howe declined to participate in the prehearing conference and therefore appears to be unaware of what occurred during the prehearing conference.

In addition, the undersigned does not and has not at any time represented the City of Dorchester or indicated such. Rather, the undersigned and other consultants for Walton Texas, LP have been assisting the City of Dorchester with the application. *See* Exhibit A hereto. The fact that the undersigned may have been erroneously listed as the City of Dorchester's counsel by the City of Howe or others has no bearing on whether Walton Texas, LP's Motion to Intervene should be granted.

Walton Texas, LP has previously participated extensively in proceedings related to the application, and having been allowed such participation, did not believe that a formal motion to intervene was necessary. And, because Walton Texas, LP has already been participating in this

proceeding, there will be no disruption if Walton Texas, LP is formally named a party. Again, Walton Texas, LP owns the bulk of the land proposed to be included in the City of Dorchester's Certificate of Convenience and Necessity and has requested water service from the City of Dorchester. Clearly, Walton Texas, LP has a justiciable interest that is affected by the application.

WHEREFORE, PREMISES CONSIDERED, Walton Texas, LP hereby again respectfully requests that it be admitted as a party in the above-referenced matter.
