COMMISSION STAFF'S REQUEST FOR EXTENSION

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Request for Extension, and would show the following:

I. BACKGROUND

On August 28, 2014, Inline Development LLC (Inline) filed an Application for Water and Sewer Rate/Tariff Change (Application) for water Certificate of Convenience and Necessity (CCN) No. 12946 and sewer CCN No. 20879 in Harris County. In Order No. 9, the administrative law judge granted Staff's request for an extension, and set July 31, 2015 as the deadline for Staff to either request a hearing or to issue a final recommendation. Therefore, this pleading is timely filed.

II. REQUEST FOR EXTENSION

Pursuant to 16 Tex. Admin. Code 22.4(b) (TAC), Staff may request the time for filing any documents be extended for good cause. In addition, 16 TAC 24.28(3) requires that Staff request a hearing within 120 days of the effective date of the rate. Staff has been working with Inline to provide additional information. Inline is attempting to obtain the documentation to supplement its application, and the parties request good cause to extend the procedural schedule as set out below. Staff is authorized to represent that Inline does not object to the extension.

III. PROCEDURAL SCHEDULE

Staff proposes the following procedural schedule:
