**COMMISSION STAFF'S REQUEST FOR EXTENSION**

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Request for Extension, and would show the following:

**I. BACKGROUND**

On August 28, 2014, Inline Development LLC (Inline) filed an Application for Water and Sewer Rate/Tariff Change (Application) for water Certificate of Convenience and Necessity (CCN) No. 12946 and sewer CCN No. 20879 in Harris County. In Order No. 9, the administrative law judge granted Staff's request for an extension, and set July 31, 2015 as the deadline for Staff to either request a hearing or to issue a final recommendation.

**II. REQUEST FOR EXTENSION**

Pursuant to 16 Tex. Admin. Code 22.4(b) (TAC), parties may request the time for filing any documents be extended for good cause. Staff has been working with Inline to provide additional information. On August 11, 2015, Inline contacted Staff requesting additional time to obtain the required documentation to supplement its application, and the parties request good cause to extend the procedural schedule as set out below.

Staff proposes the following procedural schedule:


