SOAH ORDER NO. 2  
MEMORIALIZING PREHEARING CONFERENCE, ADOPTING PROCEDURAL  
SCHEDULE AND NOTICE OF HEARING

I. PREHEARING CONFERENCE

On June 23, 2016, the undersigned Administrative Law Judge (ALJ) convened a prehearing conference in this case. Staff of the Public Utility Commission and Applicant Inline Development LLC appeared. The parties submitted an agreed scheduling order, which is adopted below. Applicant requested that it be allowed to present live rebuttal testimony rather than prefiled rebuttal testimony because rebuttal testimony is expensive and Applicant is a small provider. Staff argued that Applicant must show good cause pursuant to 16 Texas Administrative Code § 22.225(a)(1) and that good cause has not been shown. The ALJ agrees that the Applicant has not shown good cause. Therefore, pursuant to the procedural schedule below, rebuttal testimony shall be prefiled.

II. PROCEDURAL SCHEDULE

The following procedural schedule is adopted in this case:

DEADLINE	ACTIONS TO BE COMPLETED
January 18, 2017	<u>Applicant Pre-filed Direct Case.</u> Applicant shall file all pre-filed direct testimony and exhibits it intends to offer in its direct case.
March 1, 2017	<u>Staff Pre-filed Direct Case.</u> Staff shall file all pre-filed direct testimony and exhibits it intends to offer in its case-in-chief.
March 15, 2017	<u>Objections.</u> Staff and Applicant shall file objections to pre-filed testimony.
April 12, 2017	<u>Applicant Pre-filed Rebuttal Case.</u> Applicant shall file all pre-filed testimony and exhibits it intends to offer in its rebuttal case.

DEADLINE	ACTIONS TO BE COMPLETED
April 19, 2017	<u>Objections to Rebuttal.</u> Staff shall file all objections to Applicant's pre-filed rebuttal testimony.
April 26, 2017	<u>Response to Objections.</u> Applicant shall file its response to Staff's objections to its rebuttal testimony.
May 8-9, 2017	<u>Hearing on the Merits.</u>

### III. NOTICE OF HEARING

The ALJ will convene the hearing on the merits in this case at 9:00 a.m. on May 8-9, 2017, at the SOAH hearing rooms located at the William P. Clements Office Building, 300 West 15th, Fourth Floor, Austin, Texas.
