**SOAH ORDER NO. 3  
GRANTING JOINT MOTION TO ADMIT EVIDENCE; DISMISSING CASE FROM  
SOAH DOCKET; REMANDING CASE TO THE COMMISSION**

On December 14, 2016, Inline Development LLC (Inline) and the staff (Staff) of the Public Utility Commission of Texas (Commission) filed a joint motion to admit evidence, to dismiss this case from the docket of the State Office of Administrative Hearings (SOAH), and to remand it to the Commission (Motion). The basis of the Motion is that the parties have reached a unanimous stipulation and settlement agreement (Stipulation) resolving all issues in this case. The Stipulation is attached to the Motion. The Administrative Law Judge (ALJ) concludes that the Motion has merit and it is **GRANTED**.
