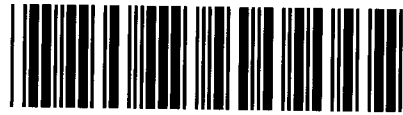

**COMMISSION STAFF'S SUPPLEMENTAL PROCEDURAL SCHEDULE**

Commission Staff (Staff) of the Public Utility Commission of Texas (Commission) files its Supplemental Procedural Schedule. In support of its Supplemental Procedural Schedule, Staff states the following:

**I. Background**

On September 9, 2014, J&S Water Company, LLC (J&S Water) filed an application requesting approval of the sale and transfer of a water system and sewer system and corresponding certificates of convenience and necessity (CCN Nos. 12085 and 20658) for a certificated area in Harris County, Texas. J&S Water is the seller, and Utilities Investment Company, Inc. (Utilities Investment) is the purchaser.

On July 15, 2015, the Administrative Law Judge entered Order No. 6, which established July 28, 2015 as the deadline for J&S Water and Utilities Investment to file an affidavit regarding notice of their application to the parties entitled to receive notice.

On July 28, 2015, Utilities Investment filed an affidavit regarding the provision of notice of J&S Water and Utilities Investment's application to the parties entitled to receive notice. Notice of J&S Water and Utilities Investment's application was sent on July 10 and 20, 2015.

On July 28, 2015, the Administrative Law Judge entered Order No. 7, which established August 10, 2015 as the deadline for Staff to file a supplemental procedural schedule for the processing of J&S Water and Utilities Investment's application. Staff's Supplemental Procedural Schedule is timely filed.

**II. Supplemental Procedural Schedule**

Staff recommends that the Commission adopt the following supplemental procedural schedule for the processing of J&S Water and Utilities Investment's application:

Event	Date
Deadline to intervene and deadline for intervenors to request a hearing (30 days from the July 20, 2015 provision of notice)	August 19, 2015
Deadline for Commission Staff to request a hearing or file its recommendation on final disposition	September 14, 2015
Deadline for J&S Water and Utilities Investment to respond to Commission Staff's recommendation on final disposition or, if no disputed issues, deadline for parties to file a joint proposed notice of approval	September 28, 2015
120-day deadline for Commission action on J&S Water and Utilities Investment's application (120 days from the July 20, 2015 provision of notice)	November 17, 2015

### III. Conclusion

Staff recommends that the Commission adopt the supplemental procedural scheduled detailed above.
