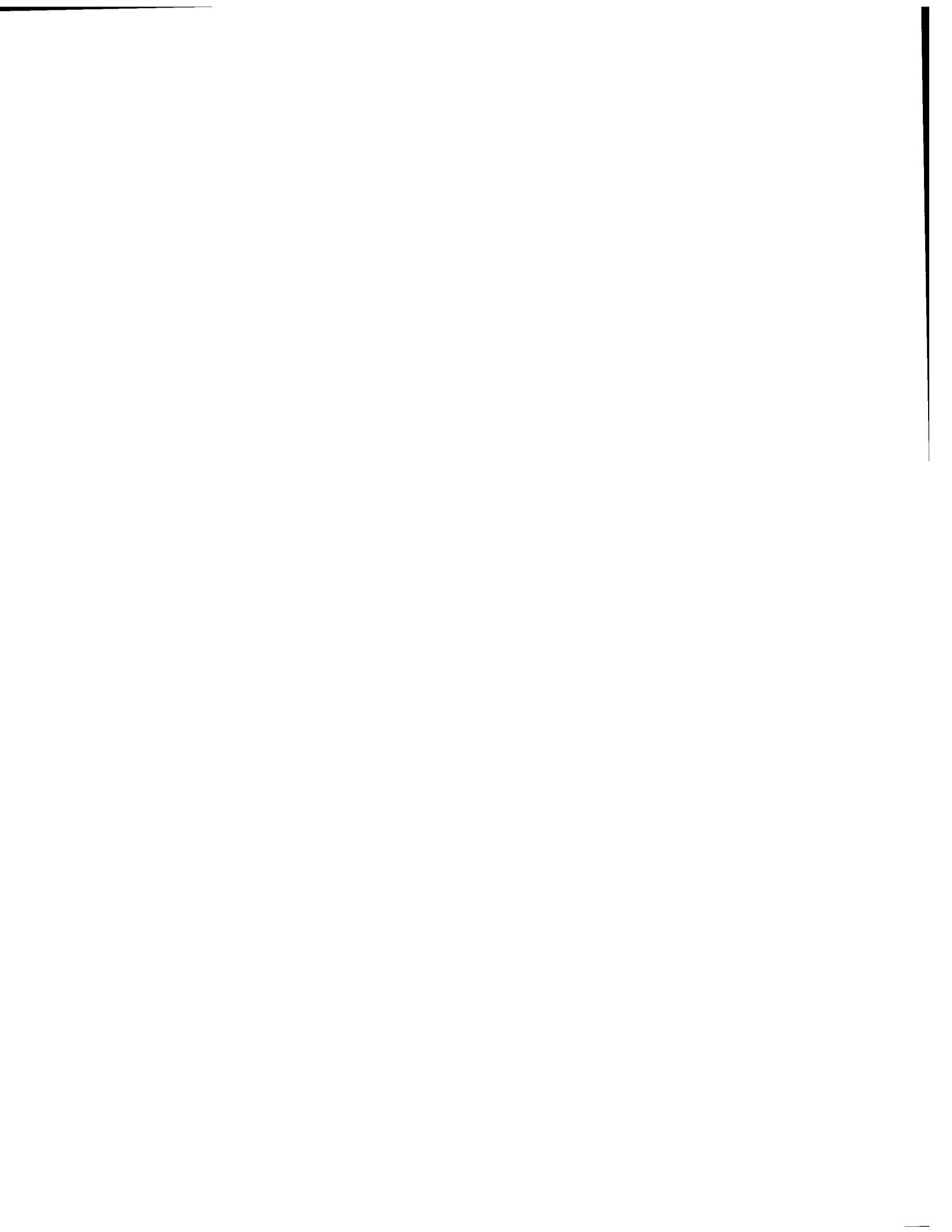

**JOINT MOTION TO ABATE PROCEDURAL SCHEDULE AND FOR

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE VICKERY:

COMES NOW Fremont Water Company and files this Joint Motion to Abate Procedural Schedule and for Expedited Consideration on behalf of itself, the Staff of the Public Utility Commission of Texas, Don and Mary Allen, and Christine Chartier (collectively, the Parties). The Parties have reached agreement in principle towards resolution of all issues in this docket. Accordingly, the Parties request abatement of the current procedural schedule in order to facilitate discussions towards finalizing the settlement. 
