FIELD NOTES FOR A 124.098 ACRE TRACT IN THE JUAN ZAMBRANO SURVEY NO. 37, J.L. HUME SURVEY NO. 52 AND J.H. DENSON SURVEY NO. 36, TRAVIS COUNTY, TEXAS.

BEING a 124.098 acre tract or parcel of land out of and being a part of the Juan Zambrano Survey No. 37, A-845, J.L. Hume Survey No. 52, A-2336, and J.H. Denson Survey No. 36, A-234, in Travis County, Texas, and being all of that certain tract said to contain 123.3 acres described in a deed from Don Raumaker to Richard C. Baker, dated February 14, 1964, recorded in Volume 2727, Page 103, Travis County Deed Records. Herein described tract or parcel of land being more particularly described by metes and bounds as follows:

BEGINNING at a 1/2 inch iron rod found at a fence corner in the west line of Engleman Road, the northeast corner of that certain 40.0 acre tract described in a deed from Hedwig Schmidt, et al, to the Veteran's Land Board of Texas, recorded in Volume 4054, Page 1274, Travis County Deed Records, for the southeast corner of this tract. Said point being at or near the east line of the before mentioned J.L. Home Survey No. 52.

THENCE with the north line of the said 40.0 acre tract, N 59 deg. 33 min. 48 sec. W, 1562.88 feet to a 1/2 inch iron rod found at a fence corner, the northwest corner of the 40.0 acre tract and northeast corner of that certain 5.35 acre tract described in a deed from Gary T. MacInnis, et ux, to Ila Packett, recorded in Volume 12681, Page 664, Travis County Deed Records, for an angle corner of this tract.

THENCE with the north line of the Packett 5.35 acre tract, N 59 deg. 50 min. 46 sec. W, 188.60 feet to the northwest corner of same, a 1/2 inch iron rod found at a fence corner, the northeast corner of that certain 15.00 acre tract described in a deed from Jeffrey L. Hayes, et ux, to Scott A. Clevinger, recorded in Volume 11777, Page 273, Travis County Deed Records, for an angle corner of this tract.

THENCE with the north line of the Clevinger 15.00 acre tract and north line of that certain 10.00 acre tract describe din a deed from Jean D. Neal to Dale Clawson, et ux, recorded in Volume 9008, Page 23, Travis County Deed Records, N 59 deg. 27 min. 54 sec. W, 502.76 feet to a 1/2 inch iron rod found at the northwest corner of the Clawson 10.00 acre tract and the northeast corner of the Alfonso H. Moreno 20.88 acre tract, for an angle corner of this tract.

THENCE with the north line, as fenced, of the Moreno 20.88 acre tract, N 59 deg. 43 min. 48 sec. W, 769.73 feet to the northwest corner of same, a 5/8 inch iron rod set near a fence corner in the east line of that certain 137.36 acre tract described in a deed from Marvin Hamann to Calvin Hamann, et ux, recorded in Volume 3975, Page 2233, Travis County Deed Records, for the southwest corner of this tract. THENCE with the east line of the Hamann 137.36 acre tract and east line of that certain 100 acre tract described in a deed from Sarah Jane Becker to Wilbert Alvin Becker, recorded in Volume 5956, Page 322, Travis County Deed Records, N 30 deg. 00 min. 00 sec. E, at 416.96 feet pass a 1/2 inch iron rod found at a fence corner, the northeast corner of the Hamann 137.36 acre tract and southeast corner of the Becker 100 acre tract, continuing 1928.19 feet for a total distance of 2345.15 feet to an axle found at a fence corner in the south line of that certain 95.6 acre tract described as Tract No. One in a deed from Fritz W. Melber, et al, to Robert Allen Tharp, recorded in Volume 1173, Page 163, Travis County Deed Records, the northeast corner of the Becker 100 acre tract, for the northwest corner of this tract.

THENCE with the south line, as fenced, of the Allen Tharp 95.6 acre tract, S 59 deg. 49 min. 35 sec. E, 501.52 feet to the southeast corner of same, a 5/8 inch iron rod set at a fence corner in the west line of that certain 60.09 acre tract described in a Contract of Sale and Purchase from the Veteran's Land Board of Texas to William H. Davis, recorded in Volume 1279, Page 508, Travis County Deed Records, for an angle corner of this tract.




