**ORDER NO. 8  
DEEMING CLOSING DOCUMENTATION SUFFICIENT AND  
ESTABLISHING PROCEDURAL SCHEDULE**

On December 5, 2014, Order No. 6 in the above-styled and numbered docket approved the sale/transfer to proceed. On April 29, 2015, Nerro filed closing documents in response to Order No. 6. On May 13, 2015, Public Utility Commission of Texas (Commission) Staff found that the warranty deed and bill of sale submitted by Nerro on April 29, 2015, was only signed by Brazos Valley, the grantor of the transaction, but the notice of assignment was signed by both parties. On June 3, 2015, Nerro filed a letter signed by both parties, as requested by Staff, which shows the transaction has been completed.

On June 17, 2015, Commission Staff filed a final recommendation regarding the sufficiency of the closing documents and proposed a schedule for the continued processing of this docket. Commission Staff stated the Applicants have submitted sufficient documentation showing the sale has been completed and that customer deposits have been properly transferred or refunded. Commission Staff proposed a procedural schedule, including a deadline for Applicants to sign and return their consent forms.

Consistent with Commission Staff's recommendation, Applicants' documentation that the sale has been completed and that customer deposits have been properly transferred or refunded is sufficient. The following procedural schedule is approved, as proposed:

EVENT	DATE
Deadline for Commission Staff to submit revised maps and certificates to the parties for consent	July 17, 2015
Deadline for parties to file completed and signed consent forms with the Commission	August 7, 2015
Deadline for Commission Staff to file a final recommendation on the application	September 4, 2015
If no disputed issues, deadline for parties to file a proposed notice of approval with findings of fact, conclusions of law, and ordering paragraphs.	September 18, 2015
