**ORDER NO. 2
REQUIRING COMMENTS ON STATUS**

I. Application

On May 28, 2014, Brazoria County Municipal Utility District No. 22 (Brazoria) filed with the Texas Commission on Environmental Quality (TCEQ) two applications requesting new water and sewer Certificates of Convenience and Necessity (CCN), respectively, in Brazoria and Fort Bend Counties. Brazoria also requests dual certification with the City of Pearland and Brazoria County Municipal Utility District No. 21. The applications were received by the Public Utility Commission of Texas (Commission) on September 19, 2014. Brazoria's water application was assigned Docket No. 43119 and its sewer application was assigned Docket No. 43120.

II. Consolidation

Since both dockets involve identical parties and involve common questions of law and fact, consolidation would serve the interest of efficiency without prejudicing any present or future parties.


Docket Nos. 43119 and 43120 are hereby consolidated into Docket No. 43119. All filings shall be made to Docket No. 43119 and styled as follows: *Application of Brazoria County Municipal Utility District No. 22 for Certificates of Convenience and Necessity and for Dual Certification with the City of Pearland and Brazoria County Municipal Utility District No. 21 in Brazoria and Fort Bend Counties (37946-C) and (37947-C).*

III. Status Update

In order to ensure the continued processing of the consolidated application, on or before **November 3, 2014**, Commission Staff shall file an update on the status of the consolidated application, a recommendation on the need for a hearing or on final disposition of the consolidated application, if appropriate at this time, or propose a procedural schedule, if necessary.
