## SOAH ORDER NO. 1 CASE DESCRIPTION, NOTICE OF PREHEARING CONFERENCE, AND FILING REQUIREMENTS

#### I. DESCRIPTION OF CASE

On May 9, 2014, the City of Patton Village (Patton Village) filed with the Texas Commission on Environmental Quality (TCEQ) an application to acquire facilities and transfer certificate of convenience and necessity (CCN) No. 12574 held by Peach Creek Dam & Lake Club, Inc. to Patton Village under Texas Water Code § 13.301. On June 6, 2014, TCEQ accepted the application for filing. On June 11, 2014, Patton Village completed notice by mail, which triggered the 120-day notification period under P.U.C. Subst. R. 24.109(a)(2). On August 5, 2014, TCEQ notified Patton Village that it had failed to meet the necessary financial and managerial capabilities under P.U.C. Subst. R. 24.109(b), and requested that Patton Village provide updated 2013 audited financial statements. On August 26, 2014, Patton Village submitted audited financial records requested by TCEQ.

Effective September 1, 2014, functions relating to the economic regulation of water and sewer utilities transferred from TCEQ to the Public Utility Commission of Texas (Commission); therefore, effective September 1, 2014, the Commission acquired jurisdiction of this case. Under P.U.C. Subst. R. 24.109(e), prior to the expiration of the 120-day notification period, the

Commission shall either approve the sale administratively or require a hearing to determine if the transaction will serve the public interest.

On October 1, 2014, after a review of the application and documents submitted by Patton Village, Commission Staff was unable to determine if Patton Village has the adequate financial capability to ensure continuous and adequate utility service under the Texas Water Code and Commission rules. Staff requested that his case be referred to the State Office of Administrative Hearings (SOAH) for a hearing on the merits.

On October 3, 2014, the Commission referred this case to SOAH, requesting the assignment of an Administrative Law Judge (ALJ) to conduct a hearing and issue a proposal for decision, if such is necessary. On October 6, 2014, SOAH assigned the undersigned ALJ to this case. SOAH has jurisdiction over matters relating to the conduct of the hearing in this proceeding pursuant to Texas Government Code § 2003.049. The Commission will consider this case at its November 14, 2014 open meeting and subsequently issue a preliminary order.

# II. NOTICE OF PREHEARING CONFERENCE

The ALJ will convene a prehearing conference at 10:00 a.m. on Thursday, November 20, 2014, in a SOAH hearing room located on the Fourth Floor of the William P. Clements Building, 300 West 15th Street, Austin, Texas. At the prehearing conference, the ALJ will address a procedural and discovery schedule, a hearing on the merits date(s), a protective order if necessary, notice, and any other issues that will assist in the fair disposition of this case. If there are any objections to the notice provided in this case, those objections shall be filed no later than October 24, 2014.

### III. FILING AND SERVICE PROCEDURES

All pleadings shall be filed with the Commission's filing clerk, not with the SOAH filing clerk. The Commission's filing clerk will forward a copy of the pleadings to SOAH. The parties
