COMMISSION STAFF'S REQUEST TO REVISE PROPOSED PROCEDURAL SCHEDULE

COMES NOW the Staff of the Public Utility Commission of Texas, representing the public interest, and files Commission Staff's Request to Revise the Proposed Procedural Schedule and would show the following:

I. BACKGROUND

On August 25, 2014, Carol Gillespie (Complainant) filed a complaint against Avalon Water Supply and Sewer Services Corporation (Avalon) alleging violations of Tex. Govt. Code 551.001(3) and Avalon's bylaws.¹ This complaint can be found on the Commission's Interchange as Item No. 1.

The economic regulation of water and wastewater utilities was transferred from the Texas Commission on Environmental Quality (TCEQ) to the Commission effective September 1, 2014. As part of that transfer, Ms. Gillespie's complaint was transferred to the Commission and scanned into the Commission's interchange on September 16, 2014. On September 30, 2014, and October 6, 2014, Ms. Gillespie filed additional materials supplementing her complaint.

On January 30, 2015, Staff filed a procedural schedule, which the Commission administrative law judge (ALJ) adopted in Order No. 1, issued February 2, 2015.

II. ADDITIONAL MATERIALS SUPPLEMENTING COMPLAINANT

Subsequent to reading Staff's January 30, 2015 filing, Complainant contacted Staff and indicated that her original complaint was contained in a July 14, 2014 letter to the TCEQ, not August 25, 2014 as Staff stated in that January 30th filing. The July 14, 2014 letter was located in materials from the TCEQ transfer, and those materials were scanned into the Commission's Interchange on February 6, 2015.

III. REVISED PROCEDURAL SCHEDULE

Staff proposes that in light of the additional materials necessary for review in this docket, the procedural schedule be revised as follows:
