I have audited the accompanying financial statements of the governmental activities, the business-type activities, each major fund, and the aggregate remaining fund information of Avalon Water Supply & Sewer Service Corporation, as of and for the year ended December 31, 2011, which collectively comprise the Corporation's basic financial statements as listed in the table of contents. I conducted my audit in accordance with auditing standards generally accepted in the United States of America. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. I believe that my audit provides a reasonable basis for my opinions.

In my opinion, the financial statements referred to above present fairly, in all material respects, the respective financial position of the governmental activities, the business-type activities, each major fund, and the aggregate remaining fund information of Avalon Water Supply & Sewer Service Corporation, as of December 31, 2011, and the respective changes in financial position and cash flows, where applicable, thereof for the year then ended in conformity with accounting principles generally accepted in the United States of America.

Accounting principles generally accepted in the United States of America require that the management's discussion and analysis on pages 4 through 6 be presented to supplement the basic financial statements. Such information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. I have applied certain limited procedures to the required supplementary information in accordance with auditing standards generally accepted in the United States of America, which consisted of inquiries of management about the methods of preparing the information and comparing the information for consistency with management's responses to my inquiries, the basic financial statements, and other knowledge I obtained during my audit of the basic financial statements. I do not express an opinion or provide any assurance on the information because the limited procedures do not provide me with sufficient evidence to express an opinion or provide any assurance.

MANAGEMENT'S DISCUSSION AND ANALYSIS

Within this section of the Avalon Water Supply & Sewer Service Corporation (the Company) annual financial report, the Company's management provides narrative discussion and analysis of the financial activities of the Company for the year ended December 31, 2011. The Company's financial performance is discussed and analyzed within the context of the accompanying financial statements and disclosure following this section.

Financial Highlights

The Company's assets exceeded its liabilities by \$720,888. This compares to the previous year when assets exceeded liabilities by \$721,625.

Total net assets are comprised of the following:

- Capital assets of \$913,751 include property and equipment, net of accumulated depreciation.
- 2. Unrestricted net assets are \$(228,834).
- 3. Assets designated for membership deposits are \$35,971.

Total liabilities of the Company decreased by \$19,548 to \$384,202 during the fiscal year.

The Company had a net operating profit of \$12,188. In other words, operating revenues exceeded operating expenses by this amount.

Overview of the Financial Statements

Management's Discussion and Analysis introduces the Company's basic financial statements. The basic financial statements include: (1) government-wide financial statements, (2) fund financial statements, and (3) notes to the financial statements. The Company also includes in this report additional information to supplement the basic financial statements.

Government-wide Financial Statements

The Company's annual report includes two government-wide financial statements. These statements provide both long-term and short-term information about the Company's overall status. Financial reporting at this level uses a perspective similar to that found in the private sector with its basis in full accrual accounting and elimination or reclassification of internal activities.

AVALON WATER SUPPLY & SEWER SERVICE CORPORATION MANAGEMENT'S DISCUSSION AND ANALYSIS

The first of these government-wide statements is the Statement of Net Assets. This is the Company-wide statement of financial position presenting information that includes all of the Company's assets and liabilities, with the difference reported as net assets. Over time, increases or decreases in net assets may serve as a useful indicator of whether the financial position of the Company as a whole is improving or deteriorating. Evaluation of the overall economic health of the Company would extend to other non-financial factors such as diversification of the taxpayer base or the condition of Company infrastructure in addition to the financial information provided in this report.

The second government-wide statement is the Statement of Activities which reports how the Company's net assets changed during the current fiscal year. All current year revenues and expenses are included regardless of when cash is received or paid. An important purpose of the design of the statement of activities is to show the financial reliance of the Company's distinct activities or functions on revenues provided by the Company's members.

Both government-wide financial statements distinguish governmental activities of the Company that are principally supported by taxes and intergovernmental revenues, such as grants, from business-type activities that are intended to recover all or a significant portion of their costs through user fees and charges. Governmental activities include general government, public safety, public services, education, and culture and recreation. At December 31, 2011, the company did not have any governmental-type funds. Business-type activities include water utilities and waste management.

Fund Financial Statements

A fund is an accountability unit used to maintain control over resources segregated for specific activities or objectives. The Company uses funds to ensure and demonstrate compliance with finance-related laws and regulations. Within the basic financial statements, fund financial statements focus on the Company's most significant funds rather than the Company as a whole.

The Company utilizes only one type of fund:

Proprietary funds are reported in the fund statements and generally report services for which the Company charges customers a fee. There are two kinds of proprietary funds. These are enterprise funds and internal service funds. The Company does not utilize any internal service funds. Enterprise funds encompass the same functions reported as business-type activities in the government-wide statements. Services are provided to customers external to the Company organization such as water and sewer utilities.

Proprietary fund statements provide both long-term and short-term financial information consistent with the focus provided by the government-wide financial statements but with more detail.

Notes to the financial statements

The accompanying notes to the financial statements provide information essential to a full understanding of the government-wide and fund financial statements. The notes to the financial statements begin immediately following the basic financial statements.
