**COMMISSION STAFF'S STATUS REPORT**

**COMES NOW** the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Status Report and would show the following:

**I. BACKGROUND**

On April 21, 2016, SOAH Order No. 3 was issued, granting the Joint Motion to Temporarily Abate Discovery and Hearing Schedule, filed by Avalon Water Supply and Sewer Service Corporation (Avalon) and Carol D. Gillespie until May 20, 2016. On May 20, 2016, Staff filed a status report indicating that the parties were continuing to negotiate, and requesting to continue the abatement until June 3, 2016. SOAH Order No. 4, issued May 31, 2016, continued the abatement until June 3, 2016, and requiring the parties to file a status report or a joint revised procedural schedule at that time.

**II. STATUS REPORT**

The parties are continuing their negotiations to reach a settlement on all issues in this proceeding and request that the discovery and hearing schedule continue to be abated until June 17, 2016 to allow the Avalon Board of Directors to consider the settlement proposal. If the parties do not reach a settlement by June 17, 2016, Staff proposes that the parties file a status report or revised procedural schedule to resume the procedural schedule for this proceeding. Staff is authorized to represent that Avalon and Ms. Gillespie join in this motion.


