COMMISSION STAFF'S PROPOSED PROCEDURAL SCHEDULE

COMES NOW the Staff of the Public Utility Commission of Texas, representing the public interest, and files Commission Staff's Proposed Procedural Schedule and would show the following:

I. BACKGROUND

On August 25, 2014, Carol Gillespie filed a complaint against Avalon Water Supply and Sewer Services Corporation (Avalon) alleging violations of TEX. GOVT. CODE 551.001(3) and Avalon's bylaws.¹

The economic regulation of water and wastewater utilities was transferred from the Texas Commission on Environmental Quality (TCEQ) to the Commission effective September 1, 2014. As part of that transfer, Ms. Gillespie's complaint was transferred to the Commission and scanned into the Commission's interchange on September 16, 2014. On September 30, 2014, and October 6, 2014, Ms. Gillespie filed additional materials supplementing her complaint.

For the continued processing of this complaint, Staff proposes a procedural schedule, below.

II. PROPOSED PROCEDURAL SCHEDULE

Staff proposes the following procedural schedule:

Deadline for Avalon to respond to Ms. Gillespie's complaint.	Friday, February 20, 2015.
Deadline for Staff to file a statement of position.	Friday, March 6, 2015.


III. CONCLUSION


