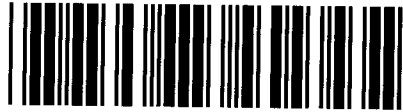

Dear Ms. Wilson:

As you are aware, the Texas Commission on Environmental Quality has received information that Tynan WSC may be in violation of one of the following items, and therefore, not operating as a non-profit WSC organized under TWC, Chapter 67.007:

- failing to conduct annual or special meetings in compliance with TWC, Chapter 67.007; or
- is operating in a manner that does not comply with the requirements for classification as a non-profit WSC.

Enclosed is a copy of our letters to you dated June 5 and July 21, 2008, requesting information about Tynan WSC in response to the alleged violations. As of the date of this letter, we have not received a response. Therefore, this matter has been referred to the State Office of Administrative Hearings (SOAH) to schedule a hearing. A date for a preliminary hearing in this matter will be scheduled and you will receive notice of the time and place for this hearing.

This matter has been assigned Docket No. 2008-1536-UR.
