Dear Board of Directors:

In June 2008, the Texas Commission on Environmental Quality's (Commission) Executive Director (ED) initiated an investigation into Tynan WSC (Tynan) pursuant to TWC §13.004. This matter was referred to the State Office of Administrative Hearings (SOAH) and a preliminary hearing was held on January 5, 2009. The Administrative Law Judge provided the Commission with a proposal for decision on May 21, 2009, recommending that the Commission has jurisdiction over Tynan pursuant to TWC §13.004 for failing to conduct annual or special meetings in compliance with TWC §67.007; or for operating in a manner that does not comply with the requirements for classifications as a nonprofit water supply or sewer service corporation. Subsequently, the ED learned that Tynan had undergone a change in management. At that time, the ED requested the Commission remand the case to the ED for further consideration. The ED now believes sufficient time has passed for Tynan to have come into compliance with section TWC §67.007. Accordingly, we are now requesting the following information:

- The name of Tynan's registered agent
- A copy of Tynan's latest tariff
- A copy of Tynan's Articles of Incorporation
- A copy of Tynan's By-laws
- The minutes of all board and/or general membership meetings since 2009
- The amount of receipts collected from water sales including the amount of regulatory assessment fees paid to the TCEQ since 2009
- Documentation relating to money/salaries paid to all full time and contract employees

- Since 2009. Indicate the name of the employee or contractor when producing the items
- All documentation establishing the full names of all active board members and the dates they were elected
- A list of all the names and addresses of all current water customers of Tynan
- A list of all the names and addresses of all current sewer customers of Tynan
- A list of all the names and addresses of all current members of Tynan
