## SOAH ORDER NO. 3 ADOPTING PROCEDURAL SCHEDULE AND NOTICE OF HEARING

On March 26, 2015, the Staff of the Public Utility Commission of Texas (Commission) filed a jointly-proposed procedural schedule. The schedule is ADOPTED as set out below.

Additionally, evidentiary objections to pre-filed testimony, if any, are due within five working days after receipt of the testimony. Responses are due within three working days.

Commission Staff is responsible for notifying the parties of the time of and place where the settlement discussions will be held.

The hearing on the merits will convene at 10:00 a.m. on August 20, 2015, at the hearing facilities of the State Office of Administrative Hearings, William P. Clements Office Building, 300 West 15th, Fourth Floor, Austin, Texas.<sup>1</sup>
