## PRE-FILED DIRECT TESTIMONY OF JOHN W. BIRKHOFF, P.E. IN SUPPORT OF THE CITY OF RED OAK'S PROTEST OF SALE, TRASNFER OR MERGER OF FACILITIES AND CERTIFICATE RIGHTS IN ELLIS COUNTY, TEXAS

My name is John W. Birkhoff. My business address is 11910 Greenville Avenue, Suite 600, Dallas, Texas 75243. I am a Principle with Birkhoff, Hendricks & Carter, LLP. I serve this firm as a licensed professional engineer in Texas. I have been licensed as a professional engineer with the State of Texas since 1983 and have been a Principle with this firm since 1983. I hold a Bachelor's of Science degree in Civil Engineering from the University of Texas at Austin. I am a current member of the American Council of Engineering Companies and the American Water Works Association. I have held past leadership positions with the Texas, and am a current D107 and D110 Standards Committee Member with the American Water Works Association.

I am involved in all areas of professional engineering services offered by my firm. However, my experience is focused on civil engineering for municipal and governmental agencies. My professional experience includes project management, design, preparation of construction plans and specifications, and construction administration for wastewater lift stations, water pump stations, water and wastewater lines, water storage facilities, drainage improvements, major thoroughfares, streets, and infrastructure rehabilitation. I have also undertaken many studies and investigations including water distribution systems, wastewater collection systems, impact fee determinations, inflow/infiltration studies and SCADA systems. In doing so, I have provided services and consultations to many communities surrounding the City of Dallas, as well as Water Districts and the Texas Department of Transportation.

I have personally prepared a resume outlining my educational background and professional experience. A true and correct copy of this Resume has been presented to me as Red Oak's Exhibit A.

My firm provides consulting engineering services primarily to municipalities and other governmental agencies. Specifically, my firm provides full engineering services for the design of projects, preparation of plans and specifications, studies, construction administration, preparation of specifications, right-of-way and easement documents, condemnation hearings, value engineering, evaluation and preparation of reports and recommended alternatives, participation in the creation of capital improvement programs, water distribution, sanitary sewer and storm water hydraulic modeling, performing surveys and drafting services for municipalities' designed projects.

I have worked on several Texas public water systems projects as a professional engineer. I have worked on projects involving CCN certification as well as non-CCN projects.

I am testifying in this matter as a professional engineer in regard to public utility facilities and as to the technical and operational capabilities of the particularly retail public utility system (the "Facilities") located at or near 105 Dana Street, in Red Oak, Ellis County, Texas. My testimony will address the ability of the existing lines of these Facilities to meet the needs or demands of the certificated service area, relating to the Walter J. Carroll Water Company's Application for a transfer of ownership of the Facilities. All of the opinions I am offering in connection with my testimony are based on a reasonable degree of engineering certainty in North Central Texas, based upon my review of the information provided of the Facilities in question.

In approaching this project, I have reviewed the relevant documentation and other information provided by Community Water concerning the project and Facilities in question. Specifically, I have reviewed a System Map provided by Community Water depicting the existing facilities in 2013, and in particular, the Community Water Distribution lines.

I have reviewed and am familiar with the issues contained within the Preliminary Order concerning this matter, including the factors listed under 13.246(c) of the Texas Water Code. In preparing for my testimony in this matter I reviewed the System Map for the Facilities the Application is based upon. My testimony is based upon my extensive education, training, experience and review of information and the applicable regulations in relation to the Application, the Facilities in question and the parties.

Based on my educational and professional background, as well as my review of the System Map of the Facilities, it is my opinion that the current Community Water System in the service area is not adequate for a number of reasons. My first observation is that the Facilities do not provide adequate fire suppression support to the service area. The system does not have any fire hydrants. The system, which was constructed in 1960, has 2 inch water lines of unknown material on most of the covered streets. It is my opinion that, in its current state, the system cannot support fire hydrants. In order to be able to support fire hydrants larger lines, at least 6 inch in size, would need to be installed in order to provide adequate water pressure and water volume. This is in additional to the installation of valves, fire hydrants, and possibly, a larger

pump. In addition, the distribution lines are not installed at proper depths with adequate cover to provide protection of the water lines from freezing, breakage or tampering. My opinion of probable construction costs to meet city standards in line size, fire protection and construction requirements would be in excess of \$650,000.00. This amount could substantially increase if the existing water line material contains asbestos.

Based on the lack of fire suppression and protection of water lines, it is my opinion that the proposed sale, without any upgrades to the current system, as proposed by Walter Carroll Company, will not serve the public interest. In the event the need for fire suppression arises, or the system fails as a result of the lack of adequate protection to the water lines, the landowners, prospective landowners, tenants or residents in the applicable service area would be negatively affected.

Based upon my training, education and experience, and my review of the Application and information related to the Facilities and Applicant, it is my professional opinion that the Application should not be approved as submitted. The Walter J. Carroll Water Co., Inc. is not able to provide adequate service to the area without the upgrade improvements referenced in my testimony. Accordingly, the Utility Commission should not approve the sale, transfer and merger of the CCN in issue from Community Water Services, Inc. to Walter J. Carroll Water Co., Inc. Subject to review of further documentation and testimony of any other witnesses, this concludes my direct testimony.
