



**DEFINITIONS**

- A. **“Community”, “Carroll”, “Red Oak”, “the Company” or “you”** refers to the Community Water Service, Inc., Walter J. Carroll Water Company, Inc. or City of Red Oak and any person acting or purporting to act on their behalf, including without limitation, attorneys, agents, advisors, investigators, representatives, employees or other persons.

- Staff 1-2** If available, provide a copy of a distribution map of the purchased public water system, Red Oak Community Water Service, which details water distribution line sizes, valve locations, and customer connections.
