COMMISSION STAFF'S JOINT PROPOSED FINAL NOTICE OF APPROVAL

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Joint Proposed Final Notice of Approval. In support of this filing, Staff states the following:

I. BACKGROUND

On October 9, 2013, Orbit Systems, Inc. (Applicant or Orbit) filed with the Texas Commission on Environmental Quality (TCEQ) an application (Application) to amend its water certificate of convenience and necessity (CCN) No. 11982 in Brazoria County, Texas, pursuant to Tex. Water Code Ann. §§ 13.246(c), 13.254 and 30 Tex. Admin. Code § 291.113¹. On November 20, 2013, the TCEQ accepted the Applicant's Application for filing, and directed to parties to provide public notice pursuant to 30 Tex. Admin. Code § 291.106. On September 1, 2014, pursuant to House Bill 1600 and Senate Bill 567 of the 83rd Legislature, Regular Session, functions relating to the economic regulation of water and sewer utilities were transferred from TCEQ to the PUC. In accordance with the requirement in Order No. 3 for Staff to file a Joint Proposed Notice of Approval by February 13, 2015, this pleading is timely filed.

JOINT PROPOSED NOTICE OF APPROVAL

This Notice of Approval addresses the application (Application) of Orbit Systems, Inc. (Orbit or Applicant) to amend its water certificate of convenience and necessity (CCN) No. 11982 in Brazoria County. The Public Utility Commission of Texas Staff recommended approval of this Application. The application is approved.

The Public Utility of Commission of Texas (Commission) adopts the following finding of facts and conclusions of law:

I. FINDINGS OF FACT

- 1. On October 9, 2013, Orbit filed with the Texas Commission on Environmental Quality (TCEQ) an Application to amend and expand its water CCN No. 11982 in Brazoria County.
- 2. This area totals 35 acres and currently have 0 customers.
- 3. Orbit has received requests for service in the proposed area
- 4. TCEQ issued a Notice of Deficiency to Orbit on February 19, 2013.
- 5. On November 20, 2013, the TCEQ accepted the Applicant's Application for filing, and directed Orbit to provide public notice of its Application to affected parties in accordance

- with P.U.C. SUBST. R. 24.106 and to publish notice once each week for two consecutive weeks in a newspaper of general circulation in Brazoria County.
- 6. On May 6, 2014, Orbit provided the TCEQ with copies of the notices as well as affidavits stating that it provided notice to all proper parties on April 17, 2014 and published notice on April 19, 2014 and April 26, 2014.
- 7. On September 1, 2014, pursuant to House Bill 1600 and Senate Bill 567 of the 83rd Legislature, Regular Session, functions relating to the economic regulation of water and sewer utilities were transferred from TCEQ to the PUC.
- 8. No protests or request for hearing have been filed in this docket.
- 9. A public hearing on the merits was not necessary.
- On December 3, 2014, Commission Staff transmitted a map and tariff for CCN No.
 11982 prepared by Staff to Orbit for review and consent.
- 11. On December 4, 2014, an authorized party for Orbit signed documents consenting to the map.
- 12. The map described in Findings of Fact 10 and 11 is attached to this order.
- 13. This Joint Proposed Notice of Approval and its attachments was reviewed by Orbit, and Orbit does not object to it.
- 14. On January 20, 2015, Staff recommended that Orbit's Application be approved.

II. CONCLUSIONS OF LAW

- 1. The Commission has jurisdiction and authority over this docket pursuant to the Texas Water Code Ann. §§ 13.041, 13.241, 13.244, 13.246 and P.U.C. Subst. R. §§24.101 24.107.
- 2. Orbit is a retail public utility as defined in Texas Water Code Ann. § 13.002(19) and P.U.C. Subst. R. 24.3(41).
- 3. Public notice of the Application was provided as required by Texas Water Code Ann. § 13.246 and P.U.C. Subst. R. 24.106.

- 4. This Application was processed in accordance with the requirements of Texas Water Code Ann. § 13.241, P.U.C. SUBST. R. 24.102 and 24.105.
- 5. After considering the factors in Texas Water Code Ann. § 13.246(c), Orbit has demonstrated adequate financial, managerial, and technical capability for providing continuous and adequate service to the requested area.
- 6. Orbit has demonstrated that the Application meets the requirements set forth in the TEXAS WATER CODE ANN. §§ 13.241, 13.244, and 13.246 and P.U.C. SUBST. R. 24.101 and 24.102 to be granted an amendment to its CCN.
- 7. Pursuant to Texas Water Code Ann. § 13.246(b) Orbit demonstrated that the certificate transfer requested in this application is necessary for the service, accommodation, convenience, and safety of the public.
- 8. The requirements for informal disposition pursuant to P.U.C. PROC. R. 22.35 have been met in this proceeding.

III. ORDERING PARAGRAPHS

In accordance with these findings of fact and conclusions of law, the Commission issues the following Order.

- 1. Orbit's Application is approved.
- 2. Orbit's CCN No. 11982 is hereby amended to reflect that Orbit is to provide retail water service to the requested areas in Brazoria County.
- 3. Orbit shall serve every future customer and applicant for service within the area certified under the CCN No. 11982, and such service shall be continuous and adequate.
- 4. All other motions, requests for entry of specific findings of fact or conclusions of law, and any other requests for general or specific relief, if not expressly granted herein, are hereby denied.



L=system average line loss for preceding 12 months not to exceed 0.15
