In my opinion, Orbit Systems Inc. has demonstrated adequate financial and managerial capability to provide service to the area subject to this application. These conclusions are based on information provided by the applicant prior to this date, and may not reflect any changes in the applicant's status subsequent to this date.

### **Review**

Orbit Systems Inc. (Orbit) executed an agreement on May 29<sup>th</sup>, 2013 with D & V Development, LLC to install a 49 connection water system for the developer using funds provided by the developer up to \$69,100. The agreement indicates that there will be no additional charge to the water utility customers for installation of taps and meters within the Bayou Colony Subdivision. The area subject to this application includes 35 acres including the planned Bayou Colony Subdivision which is located approximately 3 miles southwest of downtown Manvel, on County Road 786. The built out subdivision is expected to contain 35 residences.

The application contains 38 water and 3 sewer system notices of violation and/or compliance investigations for PWS's. For the water system, 26 out of 38 compliance investigation correspondences from the TCEQ indicated either no violations or resolved violations. Five 5 TCEQ notice of violation letters had been responded to by Orbit and appear to be in the process of resolution. Seven of the notices of violation were for the 85% capacity requirement, for which Orbit has requested a waiver due to no projected growth at the system. The TCEQ notice letters for sewer systems include 1 no violation letter and two letters to which Orbit has responded. TCEQ acknowledged that one of the violations had been resolved and the other violation has been responded to, pending TCEQ review.



# **TCEQ Interoffice Memorandum**

Orbit's annual report indicate total revenues of \$1.3 million and 1850 water connections and 275 sewer connections as of December 2012. Because the plant needed to serve the new connections is to be paid for by the developer, no significant capital investment will be needed. The relative size of the subdivision (35 connections) to the total number of connections currently served (1,850) The annual report indicates sufficient revenues to cover new operations during the time build out is occurring.

TCEQ staff did not deem a balance sheet necessary because of previous reviews in 2011 and 2012. The annual report reflects a net income from operations excluding depreciation of for the period ending 10/31/2011, but the financial statements do not separately identify the current portion of long term debt in order to calculate the debt service coverage ratio. A ratio in excess of 1.25 to 1 is preferred so that the utility has ample opportunity to set up a reserve fund, but we were unable to tell if OSI meets this criteria. Given that Orbit Systems Inc. currently owns and operates 32 public water systems in 3 counties, and serves approximately 1,270 connections over 3,700 acres per the TCEQ Water Utilities Database, this transaction represents just over a 4% increase in service area and capacity of Orbit, and can be considered immaterial and unlikely to have a material effect on the operations and /or financial ability of Orbit Systems Inc. No additional financial review is considered necessary.
