#### **DEFINITIONS**

- Staff 2-1 The City incurred a Texas Commission on Environmental Quality (TCEQ) violation on November 8, 2015 for failure to maintain authorization for the discharge of wastewater into or adjacent to any water in the state, TCEQ Docket No. 2015-0747MWS-E. Please explain how the City is addressing the violation and provide any documentation from TCEQ acknowledging those measures and/or the resolution.
- Staff 2-2 Provide the TCEQ discharge permit numbers for the City of Schertz's sewer system.
- Staff 2-3 Provide the most recent sewer inspection report for the City of Schertz's sewer system.
- Staff 2-4 Provide documentation demonstrating that any issues listed in the sewer inspection report have been resolved. For any issues from that report that remain unresolved, please provide the corrective action plan and the status of that corrective action plan.
