COMES NOW, Farmers Transport Inc. dba Enchanted Harbor Utility, Applicant in the above-captioned docket and files this its Settlement and Compromise Agreement, and shows the following:

I.

The parties to this Docket (except for the PUC) have reached an agreement as follows:

- 1. In consideration of the mutual covenants and promises herein, Enchanted Harbor Utility agrees to withdraw its petition and file an Agreed Motion to Dismiss this Docket and in exchange Anita Koop hereby agrees that she shall not connect her water system to any other properties within the Certificate of Convenience and Necessity held by Enchanted Harbor Utility. Roy E. Floyd hereby agrees to not connect to Anita Koop's water system.
- 2. Should any party violate this Agreement, the non-defaulting party shall be entitled to obtain an injunction in the District Court of Travis County, Texas or in any other court of competent jurisdiction to compel enforcement of this Agreement and the prevailing party shall be entitled to an award of all reasonable attorney fees and costs incurred in such action.
