Section 1 (3 pages) was approved and signed by the Bandera County Judge and Bandera County Commissioners on July 27, 2000. Section 2 (3 pages) was approved and signed by the Bandera County Judge and Bandera County Commissioners on March 25, 2004. Copies of these two documents with Texas Registered Professional Land Surveyor's stamp and signature are enclosed.
