COMMISSION STAFF'S REQUEST FOR AN EXTENSION

Commission Staff (Staff) of the Public Utility Commission of Texas files its Request for an Extension. Staff requests that the deadline for Staff to file its recommendation or request a hearing be extended from July 20, 2015 to August 3, 2015. In support of its Request for an Extension, Staff states the following:

I. Background

On February 28, 2014, Wiedenfeld Water Works, Incorporated (Wiedenfeld Water) filed with the Texas Commission on Environmental Quality (TCEQ) an application to amend its water certificate of convenience and necessity (CCN No. 12052) for a water system located in Kerr County, Texas.

On June 2, 2015, Wiedenfeld Water filed with the Commission documents regarding TCEQ approval of Wiedenfeld Water's water plant and distribution system and documents regarding Wiedenfeld Water's finances.

On July 8, 2015, the Administrative Law Judge entered Order No. 7, which extended the deadline for Staff to file its recommendation or request a hearing to July 20, 2015.

II. Request for an Extension

The Commission's procedural rules permit deadlines to be extended upon a showing of good cause.<sup>1</sup> There is good cause in this proceeding because Staff needs additional time to review the documents filed by Wiedenfeld Water in order to determine whether Wiedenfeld Water meets the substantive requirements listed in 16 Tex. Admin. Code § 24.102. Thus, Staff requests that the deadline for Staff to file its recommendation or request a hearing be extended from July 20, 2015 to August 3, 2015. To the extent possible, Staff will file its recommendation or request a

### III. Conclusion
