**ORDER NO. 8  
DEEMING APPLICATION SUFFICIENT; ADDRESSING NOTICE AND  
ESTABLISHING PROCEDURAL SCHEDULE**

**I. Application**

On July 9, 2014, the City of Pleasanton (Pleasanton) filed an application to obtain water and sewer certificates of convenience (CCN) in Atascosa County, Texas. On December 1, 2014 and March 11, 2015, Pleasanton supplemented the application to cure deficiencies noted by Commission Staff.

**II. Administrative Completeness**

On April 22, 2015, Commission Staff filed additional comments in response to Order No. 7 on the sufficiency of the amended application and notice. Commission Staff finds that Pleasanton's application and notice, as amended, are sufficient for further review. Consistent with Commission Staff's recommendation, Pleasanton's application and notice are deemed administratively complete.

**III. Notice**

Commission Staff recommended that the City of Pleasanton provide notice and submit signed affidavits indicating that notice was given, along with a copy of the actual notices issued, within 30 days of the date of notice and last publication date. Consistent with Commission Staff's recommendation, Pleasanton shall provide notice as described in Staff's recommendation and file affidavits evidencing proof of notice by the deadline set forth below. Applicant shall provide notice using the notice forms attached to Commission Staff's recommendation.

**IV. Procedural Schedule**

The following procedural schedule is adopted:

Deadline for applicant to file with the Commission a copy of the notice sent to affected parties with signed affidavit(s) evidencing proof of notice and publication	Within 30 days of the date of notice and 30 days of the last publication date
Deadline for Intervention; deadline for intervenors to file comments or request a hearing on the merits	Within 30 days of mailing or publication of notice, whichever occurs later
Deadline for Commission Staff to file an updated procedural schedule, request a hearing, or file a final recommendation	July 29, 2015
