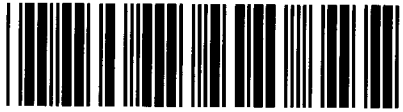

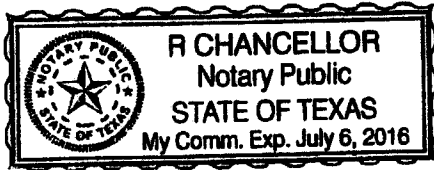

NOTICE OF APPLICATION TO OBTAIN CERTIFICATES OF CONVENIENCE AND NECESSITY (CON) TO PROVIDE WATER AND SEWER UTILITY SERVICE IN ATASCOSA COUNTY, TEXAS

The City of Pleasanton filed an application with the Public Utility Commission of Texas to obtain a water and sewer Certificates of Convenience and Necessity in Atascosa County.

The proposed water and sewer utility service areas are located approximately 3 miles to the north and south of downtown City of Pleasanton, Texas, and generally bounded on the north by the intersection of US Highway 37 and Saint Augustine; on the east by Interstate Highway 37; on the south by CR 430; on the west by State Highway 161.
