**COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY AND PROPOSED
PROCEDURAL SCHEDULE**

COMES NOW the Staff of the Public Utility Commission of Texas (Commission), representing the public interest and files this Recommendation on Sufficiency and Proposed Procedural Schedule, and would show the following:

I. BACKGROUND

On March 7, 2017, the Administrative Law Judge (ALJ) issued SOAH Order No. 13, granting Staff's request to extend the deadline until March 13, 2017 to provide a recommendation on the mapping information and recommendation on further disposition.

**II. RECOMMENDATION ON SUFFICIENCY OF MAPPING INFORMATION
AND PROPOSED PROCEDURAL SCHEDULE**

The City of Pleasanton filed the updated mapping information on March 3, 2017. After review of the filing, Staff recommends that the additional information be deemed sufficient. Staff recommends the following procedural schedule:

Event	Date
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable) to Applicant to review and consent	April 12, 2017
Deadline for Applicant to file signed consent forms with the Commission	April 26, 2017
Deadline for Staff to file a final recommendation on the Application	May 3, 2017
Deadline for Applicant to file response to Staff's final recommendation, if needed	May 10, 2017
If hearing is not needed, deadline for parties to file settlement documents and proposed order	May 19, 2017


