ORDER NO. 6 FINDING APPLICATION ADMINISTRATIVELY COMPLETE AND ESTABLISHING PROCEDURAL SCHEDULE

On April 7, 2015, Public Utility Commission of Texas (Commission) Staff recommended that the application, in combination with the supplemental filing, is sufficient and complete. In addition, Commission Staff recommended that the proposed notice be found sufficient. At this time, Commission Staff recommended that Wilderness Sound (Wilderness Sound) and HDU Services, LLC (HDU) (collectively, Applicants) proceed with provision of notice for the proposed transaction to those current customers, neighboring systems, and cities included with Commission Staff's recommendation. Finally, Commission Staff recommended that Wilderness Sound's certificate of convenience and necessity (CCN) No. 11699 maintain its name on the CCN until the transfer is complete and approved according to Commission rules. Commission Staff noted that HDU's Bill of Sale dated March 19, 2015, should not have been submitted until after the comment period of notice is complete; therefore, HDU's Bill of Sale will need to be redone and re-dated to indicate the later date.

Consistent with Commission Staff's recommendations (1) the application is administratively complete; (2) Applicants may proceed with provision of notice to current customers, neighboring systems, and cities included with Commission Staff's recommendation; (3) CCN No. 11699 shall remain in Wilderness Sound's name until the transfer is complete and approved according to Commission rules; and (4) HDU shall redo, re-date, and submit its Bill of Sale following completion of the comment period.

Commission Staff proposed a procedural schedule for continued processing of this docket. Accordingly, the following schedule shall apply:

Deadline for Applicants' affidavits of notice for mailed and published notice	May 7, 2015
Deadline to intervene and deadline for intervenors to file comments or request a hearing	30 days after mailing or publication of notice, whichever occurs later
Deadline for Commission Staff to file a supplemental procedural schedule	June 11, 2015
