ORDER NO. 10 ADMITTING EVIDENCE

- 3. Applicants' responses to Order Nos. 3 and 4, and all attachments thereto, filed January 23, 2015 and March 27, 2015, respectively;
- 4. Commission Staff's Response to Order No. 5 recommending that the application was administratively complete, and attached memorandum;
- 5. All affidavits and attached proofs of notice filed May 7, 2015;
- 6. Commission Staff's recommendation that the transaction be allowed to proceed and that no public hearing was necessary, and attached memorandum, filed June 11, 2015;
- 7. Copies of the Bill of Sale filed July 3, 2015;
- 8. Commission Staff's recommendation that submitted closing documents were sufficient, filed July 15, 2015;
- 9. Consent Forms signed by the Applicants, filed July 21, 2015;
- 10. Commission Staff's final recommendation that the application be approved, with attached memorandum, certificates, map and tariff, filed July 30, 2015;
- 11. Commission Staff's clarified final recommendation that the application be approved, with attached memorandum, proposed notice of approval and request for an order admitting evidence, certificates, map and tariff, filed September 24, 2015.
