APPLICATION OF THE CITY OF MANOR TO AMEND ITS WATER CERTIFICATE OF CONVENIENCE AND NECESSITY NO. 10947 § PUBLIC UTILITY COMMISSION § OF TEXAS §

COMMISSION STAFF'S REQUEST FOR AN EXTENSION

COMES NOW the Staff of the Public Utility Commission of Texas, representing the public interest, and files Commission Staff's Response to the Commission administrative law judge's (ALJ) November 14, 2014 Order No. 2 and would show the following:

I. BACKGROUND

On July 8, 2014, the City of Manor (Applicant) filed an application to amend its water certificate of convenience and necessity (CCN) No. 10947 in Travis County, Texas. Manor states that a single developer has requested service from Manor for a project of approximately 773 connections.¹

On October 2, 2014, Staff determined that Manor's Application was not administratively complete. In the ALJ's November 14, 2014 Order No. 2, the ALJ directed Manor, on or before December 15, 2014, to amend its application to cure the deficiencies noted by Staff and ordered that Staff file a supplemental recommendation regarding administrative completeness of the amended application and notice along with a proposed procedural schedule by December 29, 2014.

II. REQUEST FOR AN EXTENSION

Pursuant to the ALJ's November 14, 2014 Order No. 2, Staff's deadline to file a supplemental recommendation on Manor's application is December 29, 2014. Due to limited Staff resources to review mapping materials for many docketed proceedings, Staff respectfully requests an extension until Friday, January 16, 2015 to review Manor's supplemental materials and application. Staff has conferred with Manor and is authorized to represent that Manor does

not oppose this requested extension. Upon completion of review, Staff will file a supplemental recommendation regarding sufficiency of the amended application and notice and will propose a procedural schedule.

III. CONCLUSION

Staff respectfully requests that the deadline to review Manor's supplemental materials and application be extended to January 16, 2015.
