## FOURTH JOINT REQUEST FOR AN ABATEMENT

Commission Staff (Staff) of the Public Utility Commission of Texas (Commission) and the Town of Little Elm file this Fourth Joint Request for an Abatement. In support of their Fourth Joint Request for an Abatement, Staff and the Town of Little Elm state the following:

### I. Background

On April 24, 2014, the Town of Little Elm filed an application with the Texas Commission of Environmental Quality. Among the requests in the Town of Little Elm's application is an amendment to its sewer certificate of convenience and necessity (CCN No. 20931). The Town of Little Elm sought to add additional service area in Denton County, Texas. The Town of Lakewood Village is also seeking to add the same service area in Denton County, Texas. Since the filing of their respective applications, the Town of Little Elm and the Town of Lakewood Village have engaged in discussions to negotiate city boundaries.

On August 3, 2015, the Administrative Law Judge entered Order No. 11, which abated this proceeding in order to permit the Town of Little Elm and the Town of Lakewood Village to continue their discussions. Order No. 11 established September 1, 2015 as the deadline for parties to either file a request to unabated this proceeding or file a status report.

## II. Fourth Request for Abatement

Staff has conferred with the authorized representatives for the Town of Little Elm and for

Lakewood Village regarding their discussions to negotiate city boundaries. It is Staff's understanding that the Town of Little Elm and Lakewood Village have reached an agreement regarding these city boundaries. The Town of Little Elm will need additional time to amend its application (and accompanying maps) to reflect this agreement. Thus, Staff and the Town of Little Elm request that the Commission further abate this proceeding until November 2, 2015. Staff and the Town of Little Elm propose that on or by November 2, 2015, the parties will either file a request to un-abate this proceeding or a status report.

#### III. Conclusion

Staff and the Town of Little Elm request that the Commission further abate this proceeding until November 2,2015.
