RE: Town of Little Elm, Denton County Application to Amend Certificates of Convenience and Necessity Docket No. 43452

Please find enclosed the completed response to Commission Staff's Order No. 14, dated December 8, 2015. Order No. 14 stated that the application remains incomplete and deficient and that the applicant shall amend/supplement its application by January 7, 2016. Each deficiency has been listed below along with our proposed supplemental response to address them.

1. PUC Comment - The Town of Little Elm must submit another map that clearly and accurately delineates the boundary of each designated area as described and agreed upon between the Town of Little Elm and the Town of Lakewood Village;

Response - A new large scale (11"x17") map is enclosed. The color of the outer boundary of each designated area has been corrected to correspond with the colors in the agreement map between the Towns. Refer to map titled "EXHIBIT A - AGREEMENT MAP (REVISED)."

2. PUC Comment - The Town of Little Elm must submit digital data for each polygon (green, reddish and yellow) in a shapefile format, which includes the projection file used to create each shapefile. The digital data must correspond to the same proposed sewer service areas as agreed upon by the Town of Little Elm and the Town of Lakewood Village;

Response - The shapefile with projection file is included on the enclosed DVD digital data disk. Refer to shapefile named "Agreement Map.shp."

3. PUC Comment – The Town of Little Elm must submit revised large scale (detailed) maps (one water and one sewer) clearly delineating the revised proposed water and sewer service areas with enough detail to accurately locate the service areas in reference to surrounding roads, streets and highways;

Response – Revised large scale water and sewer maps are enclosed. Refer to maps titled "EXHIBIT B – WATER CCN LARGE SCALE MAP" and "EXHIBIT C – SEWER CCN LARGE SCALE MAP."

4. PUC Comment – The Town of Little Elm must submit revised digital data for the revised proposed water and sewer service areas in a shapefile format including the projection file used to create the file.

Response – The shapefiles with projection files are included on the enclosed DVD digital data disk. Refer to shapefiles named "Water\_CCN\_11202.shp" and "Sewer\_CCN\_20931.shp." The shapefiles also include attribute fields to more clearly identify each tract and reflect our intent.
