Please find enclosed the completed response to Commission Staff's Order No. 17, dated February 24, 2016. Order No. 17 stated that the application remains incomplete and deficient and that the applicant shall amend/supplement its application by March 21, 2016. Order No. 18 granted a deadline extension to April 4, 2016. Each deficiency has been listed below along with our proposed supplemental response to address them.

1. PUC Comment – *A new large scale "agreement map" that clearly and accurately delineates the outer boundary of each designated area (green, red, and yellow) as described and agreed to between the Applicant and the Lakewood Village. This map must be labeled as "Exhibit A", as referenced in the agreement. Both dockets 43145 and 43452 must provide the exact same agreement map.*

Response – A new large scale agreement map is enclosed. Refer to map titled "EXHIBIT A – AGREEMENT MAP." The exact same agreement map will be provided for both dockets.

2. PUC Comment – *Digital data for each polygon (green, red, and yellow) in a shapefile format as shown on the new agreement map, which includes the projection (PRJ) file used to create each shapefile (SHP). The digital data must correspond to the same proposed sewer service areas as referenced on a new agreement map. Both dockets 43145 and 43452 must provide the exact same digital data for each agreement area in a polygon format.*

Response – The shapefile with projection file is included on the enclosed DVD digital data disk. Refer to shapefile named "Sewer_CCN_Agreement_20075_20931.shp." The exact same digital data will be provided for both dockets.

3. PUC Comment – *Revised large scale (detailed) maps (one for water and a separate one for sewer) clearly delineating the amended water and sewer service areas with enough detail to accurately locate the areas in reference to surrounding roads, streets and highways. The map shall remove any property data, so roads, streets and highways are clearly displayed in reference to the revised proposed sewer service areas.*

Response – Revised large scale maps are enclosed. Refer to maps titled “EXHIBIT B – WATER CCN LARGE SCALE MAP” and “EXHIBIT C – SEWER CCN LARGE SCALE MAP.”

4. PUC Comment – *Revised digital data for the amended water and sewer service areas in a polygon and SHP format with the PRJ file used to create the file.*

Response – The shapefiles with projection files are included on the enclosed DVD digital data disk. The revised digital data contains no gaps or overlap with the existing CCN boundaries obtained from the PUC’s official CCN data. Refer to shapefiles named “Sewer_CCN_20931.shp” and “Water_CCN_11202.shp.”
