ORDER NO. 21

**DEEMING APPLICATION ADMINISTRATIVELY COMPLETE,
 REQUIRING NOTICE, AND ESTABLISHING A PROCEDURAL SCHEDULE**

This Order addresses Commission Staff's July 15, 2016, supplemental recommendation regarding this application. As stated in the pleading and specified in the attached memorandum of Debbie Reyes Tamayo and Tracy Montes in the Commission's Water Utility Regulation Division, Commission Staff recommended that the application be deemed administratively complete. Commission Staff also recommended that the Town of Little Elm be required to provide notice consistent with Commission Staff's recommendation, using the attached forms and with a color copy of certain large scale maps showing the proposed water and sewer service areas attached. Finally Commission Staff recommended that within 30 days of this Order, Little Elm be required to file affidavits evidencing notice was given, along with a copy of the actual notice and maps issued, and proposed a procedural schedule for continued processing of this application. Commission Staff also stated that technical review of the application might be delayed if Little Elm fails to provide written documentation from North Texas MWD and the City of Frisco allowing Little Elm to provide retail water and sewer services within portions of their boundaries.

Consistent with Commission Staff's recommendation, the application is deemed administratively complete. Little Elm shall provide notice of the application consistent with Commission Staff's July 15, 2016 pleading and the attached memorandum, using the forms attached to the memorandum and with a color copy of the large scale maps that were identified by Commission Staff attached. Little Elm shall file affidavits evidencing proof of mailed and published notice, including a copy of the actual notice and maps issued, by the deadline set forth



Event	Date
Deadline for Little Elm to file signed affidavits evidencing that mailed notice was given, including a copy of the actual notice and maps sent to the affected parties, and evidencing that notice was published in a newspaper of general circulation	August 12, 2016
Deadline for Commission Staff to file a recommendation regarding the sufficiency of the notice provided by Little Elm and propose a supplemental procedure schedule	August 26, 2016
Deadline to Intervene	30 days after notice is issued
