COMMISSION STAFF'S MOTION TO ADMIT EVIDENCE .

Commission Staff (Staff) of the Public Utility Commission of Texas (Commission) files this Motion to Admit Evidence. Staff request that certain evidence be admitted into the record in support of its Proposed Notice of Approval. In support of its Motion to Admit Evidence, Staff states the following:

I. Background

The Town of Little Elm requests an amendment to its water and sewer certificates of convenience and necessity (CCN Nos. 11202 and 20931, respectively) in order to add additional service areas. Additionally, the Town of Little Elm requests that the Commission decertify portions of certificated service areas currently served by Mustang Special Utility District, Valencia on the Lake Water Control Improvement District, the City of Hackberry, and the City of Oak Point. The Town of Little Elm's service area is in Denton County, Texas.

On January 13, 2017, Staff filed its Final Recommendation. Staff recommended that the Commission approve the Town of Little Elm's application and the requested amendments and decertifications.

On January 20, 2017 Staff filed its Proposed Notice of Approval.

II. Motion to Admit Evidence

In support of its Proposed Notice of Approval, Staff requests that the following evidence be admitted as evidence in the record:
