COMMISSION STAFF'S REQUEST FOR ADDITIONAL TIME

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest and files this Request for Additional Time, and would show the following:

I. BACKGROUND AND DISCUSSION

On July 24, 2014, the Quadvest, L.P. (Applicant or Quadvest) filed with the Texas Commission on Environmental Quality (TCEQ) an application (Application) to amend water Certificate of Convenience and Necessity (CCN) No. 11612 and sewer CCN No. 20952 in Montgomery County pursuant to TEX. WATER CODE ANN. §§ 13.242 thru 13.250 and 30 TEX. ADMIN. CODE §§ 291.101 thru 291.107. The Application was received by the Commission on October 2, 2014.

Order No. 5 allowed the Applicant until April 17, 2015 to cure the deficiencies noted by Staff on March 30, 2015. The Applicant filed supplemental information on April 21st, 23rd, and 27th. Order No. 5 allowed Staff until May 15, 2015 to file a supplemental recommendation or status update.

II. REQUEST FOR ADDITIONAL TIME

Staff continues to review the supplemental mapping information filed by the Applicant, and requests that it be allowed until May 28, 2015 to complete its review of the mapping information and file a supplemental recommendation.
