### **NOTICE ADDRESSING SUFFICIENCY, PROPOSED NOTICE AND PROCEDURAL SCHEDULE**

On October 3, 2014, Central Texas Telephone Cooperative, Inc. (CTTC) filed an application for revisions to its Local Exchange Access Tariff to increase its business and residential service line rates in the Bend, Big Valley, Cherokee, Doole/Mountainview, Eola, Evant, Locker, Lohn, Melvin, Mercury, Mullin, Priddy, Rochelle, Star, San Saba and Voca Exchanges to meet the Federal Communications Commission's local rate floor.

On October 9, 2014, Commission Staff filed a recommendation for the application to be found sufficient. Commission Staff also stated that CTTC's notice is sufficient and in compliance with P.U.C. Subst. R. 26.171

Consistent with Commission Staff's recommendation, CTTC's notice is deemed sufficient. CTTC's application is also deemed sufficient for further review. The timeline issued previously is affirmed and the dates remaining are as follows:
