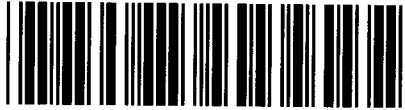

ORDER NO. 4
GRANTING MOTION TO MODIFY DISCOVERY SCHEDULE

On February 14, 2001, Applicant filed a motion to modify the discovery schedule set forth in Order No. 3. Applicant notes that the parties have agreed to mediate their dispute before a mediator on February 23, 2001. In order to avoid any unnecessary expense and time related to preparation of written discovery questions, the parties propose to modify the discovery schedule as follows:

- March 2, 2001 Deadline for serving discovery
- March 30, 2001 Deadline for serving responses to discovery

No other changes to the schedule are proposed. After considering the motion, the ALJ is of the opinion the request should be granted.

THEREFORE, IT IS ORDERED that the discovery schedule set forth in Order No. 3 be modified as above.
