#### **ORDER NO. 6**

#### REQUEST FOR STATUS REPORT FROM EXECUTIVE DIRECTOR

On October 17, 2005, counsel who represented the Applicant (Fall Creek Utility Co., Inc.) at the beginning of the captioned action submitted to the Administrative Law Judge ("ALJ") a status report, which indicated that the corporation embodying the Applicant has been wholly acquired by the Lake Granbury RV Ranch Homeowners Association – one of the parties designated as opposing the application in this proceeding.

If the Applicant, in fact, has been acquired by one of the protesting parties, the ALJ questions whether a real controversy still exists with respect to the application. Accordingly, the ALJ requests the Executive Director to submit a report by **October 25, 2005**, explaining why this proceeding should not be dismissed from the docket of the State Office of Administrative Hearings.
