### LAKE GRANBURY RV RANCH PROPERTY OWNERS ASSOCIATION AND FALL CREEK UTILITY COMPANY, INC.'S JOINT MOTION FOR ABATEMENT

#### TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

NOW COMES, LAKE GRANBURY RV RANCH PROPERTY OWNERS

ASSOCIATION (the "POA") and FALL CREEK UTILITY COMPANY, INC. ("Fall
Creek") and file this their Joint Motion for Abatement in the above referenced cause and
in support of which, would respectfully show the Administrative Law Judge as follows:

I.

1. On April 27, 2004, Fall Creek filed a rate change application with the Texas Commission on Environmental Quality ("TCEQ"). The POA protested the rate change and a hearing was held on January 25, 2005. The POA is the only party protesting the application. A mediated settlement conference was held and an agreed schedule was adopted.

II.

2. Having conducted settlement negotiations, Fall Creek and the POA reached a settlement agreement, contingent upon the TCEQ approval of the POA's stock purchase application, which was filed on March 1, 2005. The parties agree that, upon the TCEQ approval of the POA's stock purchase application, the application for a rate increase will be assigned and transferred to the POA who will either pursue the application as an uncontested matter or will withdraw the application.

3. The POA and Fall Creek are currently of the understanding that the TCEQ has approved the POA's stock purchase application, however, the parties are awaiting the written approval letter from the TCEQ.

#### III.

4. In order to allow the parties to complete all settlement negotiations and agreements and to obtain a written letter from the TCEQ approving the POA's stock purchase application, the parties request that this matter be abated for a period of ninety (90) days.

WHEREFORE, PREMISES CONSIDERED, Lake Granbury RV Ranch Property

Owners Association and Fall Creek Utility Company, Inc. respectfully request that the

Administrative Law Judge issue an order abating the procedural schedule until October 4,

2005.

### FALL CREEK UTILITY COMPANY, INC. AND LAKE GRANBURY RV RANCH PROPERTY OWNERS ASSOCIATION'S JOINT MOTION FOR ABATEMENT

TO: The Honorable Mike Rogan, Administrative Law Judge, State Office of Administrative Hearings, 300 W. 15<sup>th</sup> Street, Austin, Texas 78711

COMES NOW, Fall Creek Utility Company, Inc. and Lake Granbury RV Ranch Property Owners Association and file this Joint Motion for Abatement in the above-referenced proceeding to request that the Administrative Law Judge ("ALJ") grant the Motion.

### I. BACKGROUND

Fall Creek Utility Company, Inc. ("Fall Creek") filed an application to change its rates with the Texas Commission on Environmental Quality on April 27, 2004. The Lake Granbury RV Ranch Property Owners Association (the "POA") filed a protest and a preliminary hearing was convened on January 25, 2005. Pursuant to Order No. 1, the case was referred for mediated settlement conference and an agreed schedule was adopted.

### II. SETTLEMENT STATUS

Fall Creek and the POA have entered into settlement negotiations and have reached a settlement concerning the disposition of this case. The settlement is contingent upon TCEQ approvals of the POA's purchase of the stock of Fall Creek. An application for the stock transfer was filed with TCEQ on March 1, 2005.

The parties agree that if the stock purchase is approved, the application for a rate increase will be assigned and transferred to the POA and the POA will pursue the application as an uncontested matter (since the POA is the only protestant of the application), or the POA will withdraw the application.

### **III. REQUEST FOR ABATEMENT**

The parties hereby jointly request that that this matter be abated for a period of ninety (90) days in order to conclude and finalize the settlement negotiations and agreements and to obtain TCEQ approval of the stock purchase agreement.

### **IV. AGREEMENT OF PARTIES**

The undersigned attorney has contacted legal representatives of all of the other parties to this proceeding, and they have agreed to this abatement.

### V. CONCLUSION AND PRAYER

In accordance with the information and arguments outlined above, Fall Creek and the POA respectfully requests that the ALJ issue an order abating the procedural schedule until June 6, 2005.
