GRANTING REMAND


On April 3, 2007, a preliminary hearing in this case convened in Austin, Texas. Based on jurisdictional exhibits admitted into evidence, the jurisdiction of the State Office of Administrative Hearings to proceed was established.

The following parties were designated:

1. Petitioner Rickie L. Roddy, representing himself.
2. H & H Water Supply Corporation, represented by Jerry W. Reed, member of the Board of Directors.
3. The Executive Director of Texas Commission on Environmental Quality (ED), represented by Stephanie Skogen, staff attorney.
4. The Office of the Public Interest Counsel of the TCEQ, represented by Mary Alice C. Boehm-McKaughan, attorney.

Following announcement by the parties on the record that they had reached settlement on the disputed issues, the ED moved for remand to the agency. There being no issues requiring a contested case hearing, this matter is hereby **remanded** to the ED for further proceedings.
