Dear Judge Church:


I have advised the TCEQ that our firm will be representing H&H Water Supply Corporation in the above matter. Recently, the Board of H&H reviewed this matter and determined that H&H would offer the meter to Mr. Roddy at a very reasonable rate. To the best of my knowledge, Mr. Roddy has not yet responded to H&H's offer and H&H will need to appear at tomorrow's preliminary hearing. Because of the nature of H&H's present position and a desire by H&H to avoid unnecessary expenses, I will not be attending tomorrow's preliminary hearing on behalf of H&H WSC. 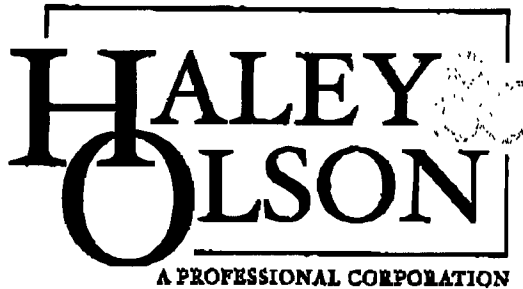
