College Mound Water Supply Corporation, North Kaufman Water Supply Corporation, and the Executive Director of the Texas Commission on Environmental Quality (ED) appeared and participated in the proceeding. The ED offered Exhibits A, B, C, and D that were admitted and established jurisdiction. The preliminary hearing was then recessed for the parties to discuss a settlement agreement. When the preliminary hearing reconvened, the parties indicated an agreement had been reached, and offered a map, which was admitted as Exhibit A-1, depicting their agreement. The ED made an oral motion that this case be remanded to the ED. The motion was granted on the record.

THEREFORE, pursuant to 30 Tex. ADMIN. CODE § 80.101, this case is dismissed from the docket of the State Office of Administrative Hearings and remanded to the ED so that an agreed order incorporating the parties' settlement can be presented to the Commission for its approval.
