ORDER NO. 4 REVISING SCHEDULE

On April 12, 2004, the Administrative Law Judge issued an order revising the procedural schedule in SOAH Docket No. 582-04-2730. That docket had been set on a concurrent schedule with these dockets. Subsequently, the Executive Director (ED) filed a motion to extend the procedural deadlines in these cases to match that in Docket No. 582-04-2730, to keep the schedules concurrent. In the motion, the ED represents that all parties (except the City of Fate) have been contacted and agree to the motion. After considering the motion, the Administrative Law Judge finds it has merit and should be granted. Accordingly, it is ordered that the following deadlines shall now govern this case:¹

May 10, 2004: Last day to propound written discovery on the parties
June 3, 2004: All discovery responses and supplementation due
June 10, 2004: All Applicants' prefiled direct testimony due
